SCOPE OF CONTRACT:

This one-year contract will be for the furnishing of general parts, accessories and supplies for all parish vehicles and motorized equipment, including dealer-type vehicles parts, accessories, supplies and automotive chemicals/agents, typically and routinely used by the Department of Central Garage in the repair and maintenance of Parish motorized vehicles, and shall be utilized on an as-needed basis. All Jefferson Parish Agencies and Municipalities may use this contract.

This contract shall be subject to the Jefferson Parish Resolution 113646 which shall be considered part of the bid and ensuing contract. A copy of Resolution 113646 may be obtained from the Office of the Parish Clerk, 6th Floor, General Government Building, 200 Derbigny Street, Gretna, Louisiana, 70053.

Parish reserves the right to award a lump sum bid to the lowest overall responsive and responsible bidder based on the discount percentage(s) offered off of manufacturer's price list(s).

Contractor shall maintain adequate stock/inventory, and distribution channels necessary to deliver required parts within two (2) hours after order placement, to either East bank or West bank locations.

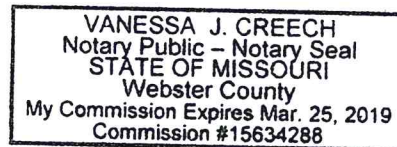
