Unless otherwise specified, all workmanship and materials must have at least one (1) year quaranty, in writing, from the date of delivery and/or acceptance of the project. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents.
