When properly installed, the Romac Style FTS 435 can work at pressures up to the maximum rating of the flange. AWWA Class D flanges, sizes 4 - 12 inch, maximum working pressure is 175 psi and a maximum test pressure of 220 psi. For flange sizes 14" and larger the maximum working pressure is 150 psi and the maximum test pressure is 188. Higher pressure ratings can be accommodated; Consult your representative.
