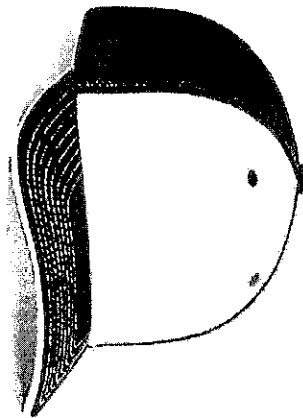

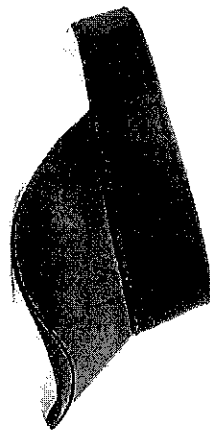

### CHANGES TO JEFFERSON PARISH BIDDING PROCEDURES
