

On motion of **Mr. Conley**, seconded by **Ms. Lee-Sheng**, the following resolution was offered:

RESOLUTION NO. 134075

A resolution **rejecting all bids** received on July 2, 2019, under Bid Proposal No. 50-00126236 for Glenwood Drive Street Lighting (Fairmont Drive to Metairie Road), Public Works Project No. 2018-012-SL, and authorizing the re-advertisement for sealed bids for the referenced project. (Council District 5)

WHEREAS, three firms submitted a bid for Proposal No. 50-00126236; and

WHEREAS, the firm of Walter J. Barnes Electric Co. was rejected due to the inclusion of an expired insurance certificate with its bid; and

WHEREAS, the firm of All Star Electric, Inc. was rejected due to failure to supply an insurance certificate with its bid; and

WHEREAS, Diamond Electrical Co., Inc. submitted the lowest responsible bid, which exceeded the project budget by 39.6%; and

WHEREAS, the original design plans and specifications, prepared by Infinity Engineering Consultants, LLC, have been modified to clarify several bid items; and

WHEREAS, these modifications will minimize the potential of exceeding the project budget.

NOW THEREFORE, BE IT RESOLVED by the Jefferson Parish Council, the governing authority of said Parish:

SECTION 1. That all bids received on July 2, 2019, by the Jefferson Parish Purchasing Department for bid Proposal No. 50-00126236, for Glenwood Drive Street Lighting (Fairmont Drive to Metairie Road), Public Works Project No. 2018-012-SL, are rejected.

SECTION 2. That the Purchasing Department be and is hereby authorized to re-advertise for sealed bids for Glenwood Drive Street Lighting (Fairmont Drive to Metairie Road), Public Works Project No. 2018-012-SL, in accordance with amended plans and specifications prepared by Infinity Engineering Consultants, LLC.

SECTION 3. That in advertising, all the usual requirements as are provided in regular Jefferson Parish advertising procedures be included in the re-advertisement, the Bid Proposal Form and Specifications for said project.

SECTION 4. That the cost of construction for Glenwood Drive Street Lighting (Fairmont Drive to Metairie Road) is to be funded from Account Number 44570-4074-7454 (45710.006).
