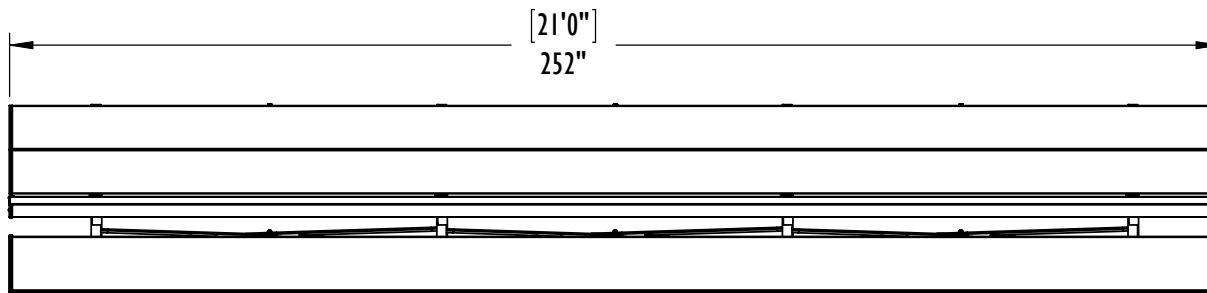

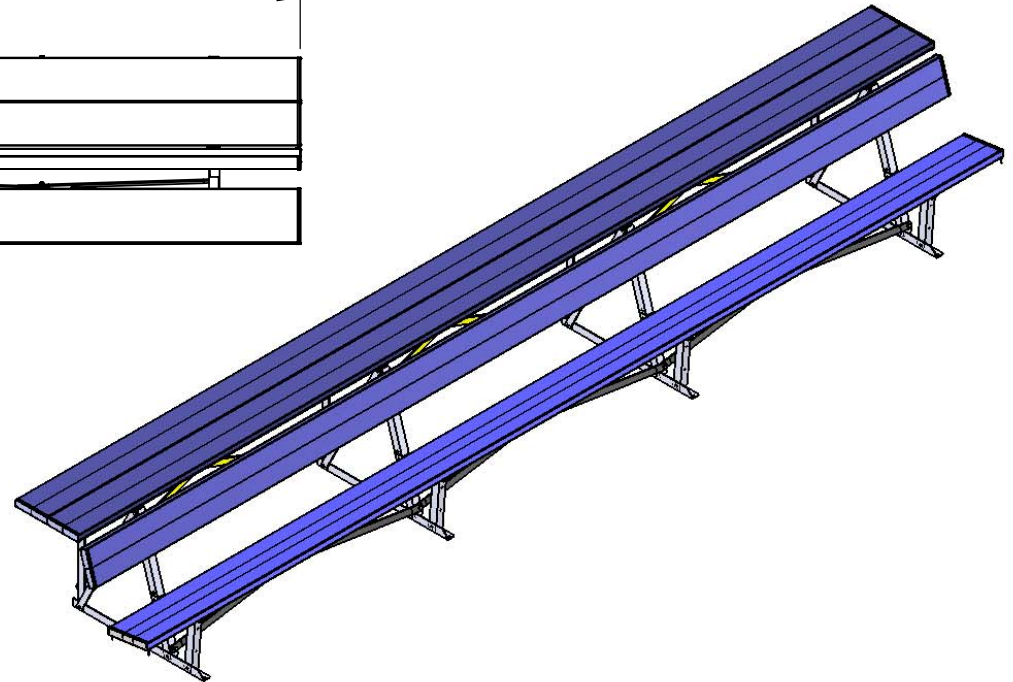


Available planking:

1. Nominal 2" x 10" x .078" thick 6063 T6 aluminum alloy available in 21', lengths, as one continuous piece. Seat planks are anodized 204-R1 while foot planks are mill finish aluminum.
2. Seat Planks are 2" x 12" (NOMINAL) .078" Clear Anodized Aluminum.

High Quality Construction:

3. Frames are fabricated from 2" x 2" x 3/16" 6061-T6 aluminum angles.
4. X braces are fabricated from 3/8" x 1-1/2" 6061-T6 aluminum flat bars.
5. Seat brackets are fabricated from 1/8" 6061-T6 aluminum extrusions.
6. All bolted joints use 1/2" diameter zinc/empigard plated bolts or 3/8" flange head nuts.
7. We use bolts for joining rather than welds to avoid stress cracking associated with welding.
8. All benches have frames that are on 6' centers with 18" of plank overhang on each end.
9. 21' benches are 4 frames wide.

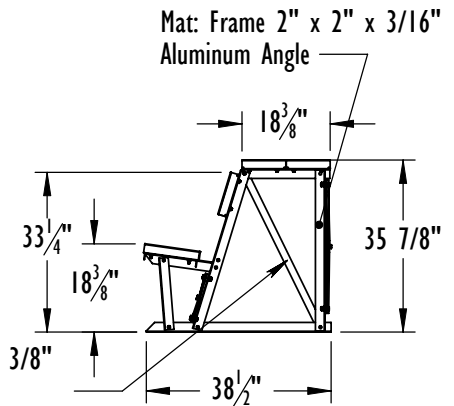
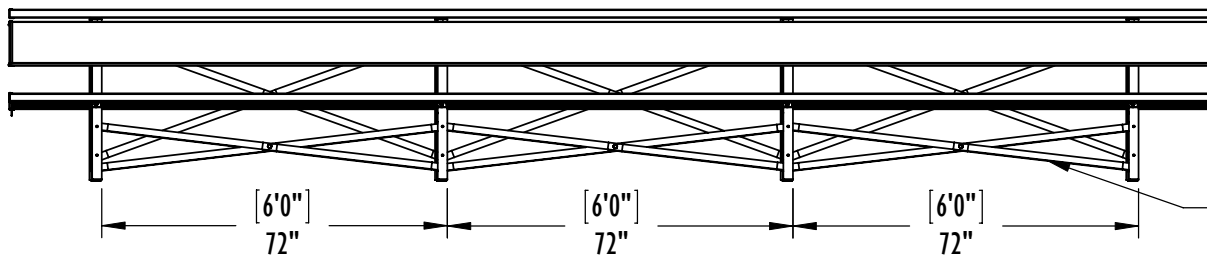
