NOTICE TO BIDDERS

Sealed proposals will be received by the Board of Supervisors of DeSoto County, Mississippi, until 10:00 a.m. on Tuesday, April 2, 2020, at the Office of Procurement, 365 Loshier Street, Suite 340, Hernando, Mississippi, for the county wide asphalt paving work for the Department of Road Management, DeSoto County, Mississippi, at which time they will be publicly opened and read aloud.

Work is to be completed by Friday, September 25, 2020.

Specifications are on file in the Office of the County Engineer at 2373 Gwynn Road in Nesbit, Mississippi, and the Office of Procurement during normal business hours. Information concerning this bid can also be found on the Procurement Page @desotocountymiss.gov at no cost or from Central Bidding at www.centralbidding.com for a fee. All bids must comply with the specifications provided. DeSoto County reserves the right to amend the specifications, as necessary, and agrees to notify all having requested bid packets from the DeSoto County Office of Procurement.

Work will be let on a unit price basis.

The County reserves the right to waive any informalities, to award or reject any and all bids or optional items, and to postpone for 45 days final decision and action on this bid.

Each bidder shall comply with the laws of the State of Mississippi for bidding procedures and licensing requirements. All bids submitted in excess of \$50,000 by a prime contractor to do any building, construction, repair, maintenance or related work must comply with Section 31-3-21, Mississippi Code of 1972, by securing a Certificate of Responsibility from the State Board of Public Contractors or by showing a statement to the effect that the bid is less than \$50,000 and Certificate of Responsibility provision does not apply, on the outside of the envelope. Bidders are to include their Certificate of Responsibility number on the outside of the envelope when applicable.

In accordance with Miss. Code. Ann. Section 31-3-21(3), preference shall be given to resident contractors. Nonresident contractors submitting a bid shall attach thereto a copy of his resident state's current preference law, if any, pertaining to such state's treatment of nonresident contractors. Failure to provide this state's resident preference law with the bid will cause the bid to be rejected.

Certified Check or Bid Bond for five percent (5%) of total bid payable to DESOTO COUNTY must accompany each proposal. The awarded bidder must provide a Performance and Payment Bond within ten (10) days of award in an amount equal to one hundred percent (100%) of the total amount of the bid.

Retainage will be held from each invoice in accordance with Miss. Code Ann. Section 19-13-15 and paid after the final acceptance of the project.

That all bids submitted must be sealed and clearly labeled on the outside of the bid envelopes as instructed in the bid package and delivered to the Office of Procurement at the above address or electronic submissions can be submitted at www.centralbidding.com. For any questions relating to the electronic submission process, please call Central Bidding at 225-810-4814. Electronic submissions will require the bidder to deliver their Certified Check or Bid Bond separately prior to the bid opening.

INVITATION TO BID

It is agreed by the undersigned bidder that this signature submission of this bid represents the bidder's acceptance and compliance of all terms, conditions, and requirements of all bid documents contained herein.

Bidders must comply with all instructions contained within this packet. Contact the DeSoto County Office of Procurement with any questions or concerns.

In accordance with Miss.Code. Ann. Section 31-3-21(3), preference shall be given to resident contractors. Nonresident bidders domiciled in a state having laws granting preference to local contractors shall be awarded Mississippi public contracts only on the same basis as the nonresident bidder's state awards contracts to Mississippi contractors bidding under similar circumstances. Resident contractors actually domiciled in Mississippi, be they corporate, individuals, or partnerships, will be granted preference over nonresidents in awarding of contracts in the same manner and to the same extent as provided by the laws of the state of domicile of the nonresident. **Nonresident contractors submitting a bid shall attach thereto a copy of his resident state's current preference law, if any, pertaining to such state's treatment of nonresident contractors. Any out of state contractor who feels they meet the residency requirements must provide evidence why they should be considered a resident contractor under 31-3-21 if their state's law is not provided. Any bid submitted by a nonresident contractor which does not include the nonresident contractor's current state law shall be rejected and not considered for award.**

In 2017 Mississippi passed legislation requiring government bidding to allow any bid to be submitted by electronic means. The DeSoto County Board of Supervisors is required to follow these laws. Electronic submission is not mandatory but is offered as a convenience to our bidders.

Electronic submission provides a way for bidders to submit their proposals without the need for printing, mailing or hand delivery of bid packets to the County. All documents are uploaded to the contracted vendor's website and transmitted to the County. There is no fee to our bidders for this service provided the bid packet is downloaded from the County's website.

ELECTRONIC SUBMITTALS DEFINITION: Secure electronic system for submittal of bids.

Bidders are required to submit their proposal in the following manner:

- Written pricing submissions may be returned via sealed envelope no later than the bid opening time clearly labeled with the bidding company name, bid date, bid number and **Certificate of Responsibility information** on the envelope. Bids may be mailed or delivered to 365 Loshier Street, Suite 340, Hernando, Mississippi, 38632, or
- Bidders may submit their complete bid packet via electronic submission to Central Bidding at www.centralbidding.com. Central Bidding is an independent firm authorized by DeSoto County to accept electronic bids for this project. **Electronic submissions will require the bidder deliver to the Office of Procurement the required Bid Bond or Certified Check no later than bid opening time.**

All written bid submissions must include one original set of proposal documents along with one paper copy. Documents required to be returned are noted throughout the bid proposal package.

All proposals must be received in the Office of Procurement or uploaded for electronic processing prior to the stated bid opening time.

1. Vendors are encouraged to read all information contained in this bid packet. All bidders are required to complete and return the provided bid documents. All requests for response shall be completed and

returned. Do not leave any blank unanswered. Failure to comply with instructions contained herein may be cause for the County to reject your bid. Only the format and documents included with this bid packet will be accepted as compliant for the submitted bid. Failure to completely complete all required attachments may result in disqualification.

2. DeSoto County reserves the right to reject all bids and re-bid or award in whole or in part.
3. The County intends to make award to the lowest bidder for the base project plus optional items in accordance with MS Code 31-7-13(d)(iv). DeSoto County reserves the right to award to the awarded bidder all or none or a portion of the optional items.
4. DeSoto County reserves the right to award all or none of the optional items and the optional items that may be awarded is subject to the availability of allocated funds for the overlay project. The County intends to make award for the base project plus optional items in accordance with MS Code 31-7-13(d)(iv) as budget allows. If at any time during the contract, the County determines the funds necessary for the completion of any road identified herein for overlay, or for the continued fulfillment of any part of the specifications, are at any time insufficient, or not forthcoming through failure of any entity to appropriate funds, or otherwise unavailable, the County may terminate the balance of the contract without penalty, liability, cost or expense by giving not less than thirty (30) calendar days' prior written notice documenting the lack of funding. In such instance where the contract is to be terminated, unless otherwise agreed to by the parties, the contract shall terminate and become null and void on the last day of the fiscal period for which County's appropriations were received, or funding was available, or ninety (90) calendar days after such notice has been delivered by County to Contractor, whichever is less.
5. The County accepts no responsibility for any expenses incurred by any bidder to participate in this process. Such expenses are to be borne exclusively by the bidders.
6. The bidder recognizes that the county will consider all aspects of the bid proposals including, but not limited to, price, ability to perform work, references, past history with DeSoto County, etc. In addition, the bidder recognizes the right of the county to reject a proposal if the bidder failed to furnish any required submittals on the date required by the proposal documents, or if any bid is in any way incomplete or irregular. Hence the Board of Supervisors may award the bid to other than the lowest bidder if in the judgment of the Board of Supervisors the interest of the county will be best served by another award. However, such judgment will be based on the circumstances mentioned or other similar conditions, if any. Final award of the bid is contingent upon vote of the Board of Supervisors.
7. Written specifications, bid package documents, and any addenda will be the basis of the bid award in accordance with Mississippi State Laws. Any significant clarifications will be handled by addenda to all vendors.
8. Whenever work or responsibilities are described in these specifications, it shall mean any work necessary to accomplish the scope of services and other descriptions of service.
9. Each bidder, by submitting a bid, represents that he/she has read and understand the bid documents.
10. The successful bidder shall comply with all State, Federal and Local laws and/or regulations.

11. The County does not intend to prevent any vendor from qualifying for participation in the bid process. Bidders are encouraged to make the Office of Procurement aware of any concerns regarding the specification requirements.
12. Bidders needing clarifications should fax or email questions as soon as possible. All questions must be sent prior to noon on **Thursday, March 26, 2020**, unless unavoidable to avoid changing the bid response date according to MS State Code 31-7-13. Only questions which change the scope of the bid

documents will be considered for addendum. Addenda will be sent to all bidders, if or when necessary until two working days prior to the bid openings. Any addenda necessary within two working days of the bid opening will require the bid date to be set back to a date not less than five (5) working days after the date of the last addendum, according to Mississippi Code 31-7-13. For that reason, bidders are encouraged to investigate this bid and ask questions within the first week of receiving the bid.

13. All addenda are to be acknowledged and submitted with the bid response.
14. The bid package shall be considered to be one bid document and all aspects of every part of the bid document shall be considered as defining the responsibility of the bidder.
15. Awarded bidders must present a Certificate of Insurance meeting stated requirements within ten (10) days of award by the Board of Supervisors.
16. Any bidder finding discrepancies in or omissions from this bid packet, or in doubt as to the true meaning of a particular requirement, shall request clarification or correction by contacting the Office of Procurement as directed above. Deadline restrictions above will apply.
17. Each bidder shall comply with the laws of the State of Mississippi for bidding procedures and licensing requirements.
18. All bids submitted in excess of \$50,000 by a prime contractor to do any building, construction, repair, maintenance or related work must comply with Section 31-3-21, Mississippi Code of 1972, by securing a Certificate of Responsibility from the State Board of Public Contractors or by showing a statement to the effect that the bid is less than \$50,000 and Certificate of Responsibility provision does not apply, on the outside of the envelope. Bidders are to include their Certificate of Responsibility number on the outside of the envelope when applicable. Bidders choosing to submit their proposal electronically through Central Bidding will provide their Certificate of Responsibility number where indicated on the website.
19. Certified Check or Bid Bond for five percent (5%) of total bid payable to DESOTO COUNTY must accompany each proposal. The awarded bidder must provide a Performance and Payment Bond referenced in this packet. **Electronic submissions will require the bidder to deliver their Certified Check or Bid Bond separately prior to the bid opening.**
20. Bidder's contract to be included in proposal. A sample contract is included in this packet but bidders may choose to submit their contract of choice for consideration.

PROJECT CONSTRUCTION INFORMATION

As far as possible, all roads will be overlaid variable widths and from 1-1/2" to 2-1/2" thick asphalt. Some of the subdivision roads will have to be less than 20 feet, but as much width as possible will be obtained. Where warranted, some roads will get more than 22 feet of width. Numerous roads will receive extra thickness as needed for strength and/or leveling. The Engineer reserves the right to lay asphalt on each road as work progresses to meet field conditions without any change in unit prices.

The Contractor will blade shoulders and perform any other work necessary to prepare for paving. There is a price in the proposal for the Contractor to do all digging out and patching.

The Contractor will be required to clean and tack the old asphalt before the overlay is started and this will be an absorbed item. In some areas, a leveling coarse may be needed ahead of the overlay and this asphalt will be paid for at the same unit price per ton as the overlay on the road. All asphalt used in patching will be a separate bid item.

MATERIAL AND CONSTRUCTION SPECIFICATIONS

The asphaltic concrete for the overlay, patching, and leveling shall conform to the specifications of the Mississippi Standard Specifications for State-Aid Road & Bridge Construction, as specified on the bid proposal items sheet as set forth in their specification manuals of latest edition, or as changed by the County Engineer.

The material shall be brought to the mechanical screener, spreader, tamping, paving machine in trucks. At the machine, the temperature of the material shall be taken and if in the required range of temperature, the material may be dumped into the spreader box.

The rate of application to the base shall be not less than 110 pounds of mix per in./sq. yd. The total of the number of square yards laid multiplied by the weight converted to tons shall at be at least equal to that which has been delivered.

Those areas laid by hand where the spreader cannot operate shall conform to the same standards. As soon as the material is laid and the paving machine is sufficiently far in advance, the freshly laid asphalt shall be rolled and the surface sealed. The Contractor must use a heavy enough roller to sufficiently roll the surface in the opinion of the Engineer. When the roller has completed its work, there shall be no roller marks, and all of the area shall drain to the ditches. The surface of the finished pavement shall not vary more than 1/4 inch. The paving machine must be capable of providing electronic slope and grade control.

The price paid for asphaltic concrete will be per ton in place and will include all labor, equipment, and material cost for furnishing, placing, and finishing the asphaltic concrete for the complete project to the satisfaction of the Engineer and County Officials.

MILLING

Milling shall be performed on areas adjacent to curbs to allow for a flush joint with the curb after the new asphalt is in place. The depth will be 1.5" at the curb line and tapering to 0" at 6 ft in from the curb as shown in the milling detail. All materials removed from the roadway surface by the milling operation shall be hauled off and disposed of by the contractor. There is not a separate pay item for the hauling and disposal and any expense incurred will be considered compensated for in the unit price for this item. Payment will be made by the square yards for material milled.

CLEAN UP

As a road is finished, the entire premises of the road shall be cleaned up, with no evidence of materials, tools, or debris left on site. At the completion of the project, the roads shall be swept and the entire premises of the job left broom clean.

PUBLIC SAFETY

The Contractor will be responsible for the safety of the traveling public and will so place flagmen, signs, and etc. during the construction of this project. The roads will not be closed, but traffic can be detained for short periods during placing of asphalt.

Temporary traffic striping shall be applied to all roadways that previously had striping by contractor immediately after paving operations.

NON PAY ITEMS AND PAYMENTS

All work for which no pay items are provided in the proposal will not be paid for directly and compensation therefor will be considered included in the prices and payment for bid items. Any questions on any phase of the work should be clarified by the Engineer before the contract is bid.

Partial payments will be paid for monthly according to Mississippi Code Annotated 19-13-15. Partial payment shall in no way be taken as final acceptance of any part of the work involved.

FINAL PAYMENT

Final payment will be made in accordance with Mississippi Code Annotated 31-5-25 and 19-13-15. The final payment or the retained percentage shall not be paid until the contractor shall satisfy the County that all liens, labor, and material bills, equipment costs or rents have been paid in full. Payment bond will be held through the guarantee period.

The final payment shall not in any way relieve the Contractor from the responsibility of his guarantee against faulty or defective materials or workmanship for a period of six months. The County will hold the awarded bidder's Performance bond through the six month guarantee period.

CLEAN UP

As a road is finished, the entire premises of the road shall be cleaned up, with no evidence of materials, tools, or debris left on site. At the completion of the project, the roads shall be swept and the entire premises of the job left broom clean.

GUARANTEE

All work performed under this contract shall be guaranteed for a period of six (6) months from the date of final acceptance of the entire job and the release of the retained percentage of payment. All repairs necessary during this period shall be done at the expense of the contractor.

SATISFACTION OF THE ENGINEER AND COUNTY FOR FINAL ACCEPTANCE

All work performed shall conform to the requirements of the specifications or as directed by the County Engineer, and shall be done in a workmanship manner such as to be acceptable and satisfactory to the Engineer and County Officials.

INSURANCE REQUIREMENTS

Prior to commencing performance of any work or supplying any materials or equipment covered by these specifications, the awarded vendor shall furnish to the Office of Procurement a Certificate of Insurance evidencing the following:

- A. **WORKERS COMPENSATION:** Statutory Limits - CONTRACTOR shall comply with all applicable Workers' Compensation laws set forth in Mississippi Code Annotated Sections 71-3-1 et. seq.
- B. **GENERAL LIABILITY** – Contractor shall carry general liability insurance coverage for the term of the agreement, naming DeSoto County as an additional insured, which shall provide coverage of claims for bodily injury, occupational sickness or disease, and death of vendor's employees or any other persons: Claims for personal injury or property damage caused by defective products: Claims for vendor's liability for injuries or property damage suffered by an party arising from the contractor's completion of

operations as the result of the negligent and/or intentional actions of contractor's employees, officers, agents and subcontractors.

Minimum insurance coverage limits and requirements are as follows:

- a. Claims for bodily injury, occupational sickness or disease, and death of vendor's employees or any other persons: claims for personal injury or property damage caused by defective products: claims for vendor's liability for injuries or property damage suffered by a third party as the result of the contractor completion of operations: claims for liability incurred by vendor as a result of entering into written contract:

\$500,000 per person

\$1,000,000 per occasion

- b. Automobile General Liability, including owned, hired, and non-owned autos:

\$500,000 per person

\$1,000,000 per occasion

- c. Claims for vendors liability for property damage suffered by DeSoto County or a third party as a result of the contractor's operations:

\$1,000,000

- C. EXCESS LIABILITY – Umbrella Form, which includes coverage for product liability. Each occurrence: **\$5,000,000**

A contract will not be executed unless a certificate of insurance evidencing above-described coverage is provided. Failure to comply during the entire period of the contract shall be deemed to be a breach of the contract. Should your insurance expire during the life of this contract, the vendor is responsible to submit a new certificate covering the remaining period of the contract. No payment will be made on a contract with an expired insurance certificate. All certificates shall indicate the names and addresses of the insurance companies, that coverage shall not be altered or cancelled without ten days' prior notice in writing to OWNER, and be approved, in writing, by agent, regularly commissioned and licensed to transact insurance business in the State of Mississippi.

BID BOND

The bid bond will be held in effect until the awarded bidder provides a performance and payment bond.

PERFORMANCE BOND

In accordance with Mississippi Code Ann. Sec. 31-5-51, DeSoto County requires the posting of a performance bond in a form satisfactory to the County. Said performance bond shall be made out in favor of DeSoto County, Mississippi and issued by a Surety company qualified and licensed to do business in the State of Mississippi and acceptable to DeSoto County, Mississippi. The foregoing notwithstanding, the intent is for the contractor to comply with and satisfy Miss. Code. Ann. § 31-5-51 and any provision herein shall be construed to insure compliance with said code section.

The performance bond will be held in effect until the County fully accepts the project as complete.

PAYMENT BOND

In accordance with Mississippi Code Ann. Sec. 31-5-51, DeSoto County requires the posting of a payment bond in a form satisfactory to the County. Said payment bond shall be made out in favor of DeSoto County,

Mississippi and issued by a Surety company qualified and licensed to do business in the State of Mississippi and acceptable to DeSoto County, Mississippi. The foregoing notwithstanding, the intent is for the contractor to comply with and satisfy Miss. Code. Ann. § 31-5-51 and any provision herein shall be construed to insure compliance with said code section.

DeSoto County will retain this bond until vendor has submitted to DeSoto County proof of satisfaction of claims and/or release of liens.

MISC. INFORMATION

There is a bid price in the proposal for digging out, hauling off bad materials, and replacing with hot mix asphalt, i.e. patching the failed areas on various roads as determined by the Engineer. The bid per ton will cover the cost of equipment, labor, digging out, and hauling off of the material. The price for asphalt will be included in the price bid for asphalt to overlay the road. The material hauled off can be placed on the shoulder of the road a short distance from each spot dug out

A list of the roads and possible areas to repair has been included in these documents as far as could be determined at the time of the writing of these documents.

CHANGES IN MATERIAL COSTS

Because of the uncertainty in estimating the costs of petroleum products that will be required during the life of a contract, adjustment in compensation for certain materials is provided as follows in accordance with MS Code 31-7-13(n):

Bituminous Products: Each month the Engineer will acquire unit prices from producers or suppliers who supply the State Highway construction industry with bituminous products. The average of all quotes for each product will serve as the base price for contracts let in the subsequent month.

Fuels: Selected cash price quotations for bulk gasoline and diesel fuel will be taken from Platt's Oilgram PAD 2 and PAD 3. The appropriate adjustment per gallon for gasoline and diesel fuel will be added to the quotations to allow for taxes and markups. The prices thus determined will serve as the base prices for contracts let in the subsequent months.

The established base prices for bituminous products and fuels will be included in the contract documents under a Notice to Bidders entitled "Petroleum Products Base Prices For Contracts Let in (Month and Year)."

Each month thereafter the Engineer will be furnished with the current monthly prices. Adjustments for change in cost will be determined from the difference in the contract base prices and the prices for the period that the work is performed and for the quantities completed provided the price change in a product is more than five percent (5%). Adjustments may increase or decrease compensation prospectively depending on the difference between the base prices and prices for the estimate period.

The adjustments will be determined for the quantities of bituminous products and the average fuel requirements for processing a unit of work as set forth herein.


