Section 1.0 – Site Visit:

All prospective bidders can schedule a site visit through Timothy Hoskins with the Department of General Services between 8:00 a.m. to 3:00 p.m. Monday Thru Friday. Mr. Hoskins can be reached at 504-364-2675

Section 2.0 – Scope:

We extend this proposal to provide labor, materials, equipment, tools, and all other incidentals necessary to replace the roof at the Local History Museum located at 519 Huey P. Long Avenue, Gretna, LA 70053.

Line item 1:

Base bid:

All work as described in these specifications, excluding section 9.0

Line Item 2:

Ancillary Work:

Provide a cost per square foot to remove, repair, and replace damaged decking material described in Section 9.0 of these specifications. This identified cost will not be part of the base bid and will not be used to determine the low bidder. This line item will only be used if needed.

Section 3.0 –License Requirements:

A Louisiana State Contractor's License will be required in accordance with LSA R.S. 37-2150 et. seq., and such license number will be shown on the outside of the bid electronic envelope. Failure to comply will cause the bid to be rejected. When submitting the bid electronically, the license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected. A copy of the license is not required by law; however, they are required to specify their license number on their bid envelope.

Section 4.0 –Bonds:

- **Surety Bond:** An Electronic bid bond will be required with bid submission in the amount of 5% of the total bid. The vendor shall indicate the electronic bid bond number in the location specified on the electronic bid envelope. No scanned paper copies of any bid bond will be accepted as part of the electronic bid submission.
- **Performance Bond:** A Performance Bond in the amount of 50% of the total contract price will be required. The performance bond shall be produced upon contract execution.

Section 5.0 – Quantities/Inspections:

Bidders must inspect the site and perform their measurements to determine the proper labor, materials, and equipment required to complete this project.

Section 6.0 – Submittals:

If the bidder intends to provide materials equal to or better than owner-specified materials, the following shall be provided with the bid submission. Provide the requested information with your bid to ensure the bid is deemed responsive.

- Manufacturer's catalog data
- Detail sheets
- Specifications of product
- Warranty information

Section 7.0 Bid Specifications:

- All materials shall be as specified new.
- All materials shall be installed as per all manufacturer recommendations and guidelines.
- Any concealed damage must be reported immediately to the Department of General Services.
- No work to conceal damages shall be performed without the Department of General Services' written approval.
- Verify that the deck is structurally sound and free of deteriorated decking. Report any damage to the Department of General Services representative immediately before any work outside these specifications is performed.

Section 7.1 Preparation:

- Remove and properly dispose of all existing roofing down to the roof deck.
- Recommended roof decks are 6" maximum width, 25/32" minimum thickness wood sheathing, 3/8" minimum thickness Exposure 1-grade plywood sheathing, or 7/16" minimum thickness non-veneer structural panels (oriented strand board panels or wafer board panels).
- Deck spacing cannot exceed ¼" between roof boards, plywood, or OSB sheathing.
- All fascia boards are to be protected from the environment by a drip edge metal flashing that will provide a minimum 20-year performance and shall be sealed to prevent moisture penetration into any enclosed space at the eaves and soffits.
- Verify that the deck is dry, sound, clean, and smooth.
- Clean deck surfaces thoroughly before installing eaves protection membrane and underlayment.

Section 7.2 -Fasteners:

- All fasteners must be driven flush with the shingle surface and penetrate at least ¾" into the wood deck. Where the deck is less than ¾" thick, the fastener should be long enough to penetrate fully and extend at least 1/8" through APA rated roof sheathing.
- Nails shall be the preferred method of attaching shingles to the wood decking or other nail-able substrates.

Section 7.3 –Underlayment:




