**Answer:** Yes, all three follower rings on the suction side of the discharge pipe are welded as stated in the plans.

**2).** When removing the weld between the pipe and dresser coupling ring the dresser coupling ring could be damaged , does the parish want to order either a complete dresser coupling or if the vendor would sell maybe only a follower ring or a middle ring ?

**Answer:** It is the design intent to leave the follower ring welded, slide the opposing ring back, and jack the pipe up to verify all gaps between the barrel (or middle ring) and the pipe are equal and aligned.

**3).** Has the designer taken into account the conflict between the existing the restraint rods and flange? During the site visit, it was observed that the restraint flange was directly centered above the concrete wall where the pipe supports are to be installed. The 12" W base plate would be hanging off the concrete wall. Note; the drawing does not show the existing flange or restraints.

**Answer:** Yes it has been taken into account. The pipe support would be located between the stiffening ring and the butterfly valve. If the bottom thrust rod is in the way, it will not be necessary to reinstall. As much of the bottom base plate shall remain on existing concrete flood wall as per plans.
