

City of Kenner and Kenner Police Department

The FIRM represents the City of Kenner in multiple premises and other liability matters, as well as defense of police liability cases. We have successfully defended the City of Kenner against tort claims involving damage caused by trees and other public property. Additionally, in a companion state court action, we were successful in having the plaintiff's claims of improper "taking" dismissed as well as a dismissal of allegations of unconstitutional denial of due process.

City of Harahan and Harahan Police Department

The Firm represents the City of Harahan and the Harahan Police Department in defense against multiple civil rights lawsuits, including 42 USC § 1983, negligence, false arrest, excessive force, unlawful discharge, due process, and whistleblower claims. New Orleans Aviation Board

New Orleans Redevelopment Authority
