PART 1. GENERAL

The bidder shall provide the following:

1. 6 each Comp-Petrol 8 inches x 10 feet SS200 Petrol USCG Composite Hose with inner and outer Galv. Wire CPLD C/S 150 pound, with fixed and floating flanges.
2. 6 each Comp-Petrol 8 inches x 20 feet Blue Petrol Composite S&D Hose CSFXFL.
3. 4 each Comp-Petrol 12 inches x 10 feet Petrol Composite S&D Hose CS FXFL Flanges.
4. 4 each Comp-Petrol 12 inches x 20 feet Petrol Composite S&D Hose CS FXFL Flanges.

PART 2 PRODUCT

Hoses shall be United Flexible Willcox hoses, or approved equal. Hoses shall be designed to transfer sewer from portable pumps to manholes or other locations. Any bids submitted for hose manufacturers, other than that as specified, must include in their bid all information needed to fully demonstrate complete compliance with requirements of these specifications. Jefferson Parish reserves the right to cancel any bids that are incomplete, or do not demonstrate that they are equal to the requirements of these specifications.

Hoses resistant Inner Wire shall be 1151GGP Galvanized Steel, 3161PGP, 3164PSP Black Polypropylene coated steel. Inner lining shall be High Grand Ploypropylene. Carcass shall be Polypropylene fabrics, films and Ploypropylene/and seamless tubes. Outer wire shall be 1151GGP, 3161PGP Galvanized Steel 3164PSP T316 Stainless Steel.

Hoses shall have the following Physical Properties:

1. Temperature Range -22° Fahrenheit to + 212° Fahrenheit
2. Maximum Elongation 10 percent on test pressure
3. Vacuum Range 26 inHg, 0.9 bar
4. Electrical Properties Electrically Conductive 1.0 ohm/m for size 2 inch

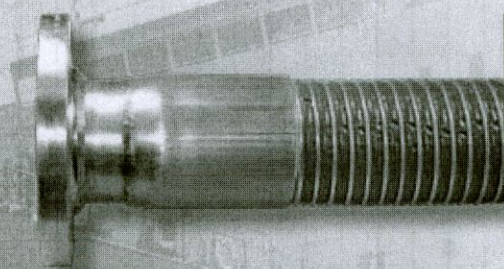


