PROPOSAL

SOUTH LAFOURCHE LEONARD MILLER, JR. AIRPORT

INSTALL INSTRUMENT LANDING SYSTEM DISTANCE MEASURING EQUIPMENT "DME"

Aviation Systems Maintenance, Incorporated proposes to provide and install a Thales 415SE DME at the South LaFourche Leonard Miller, Jr. Airport. The installation will be completed in accordance with the Scope of Work in the Specification and Contract Documents. The installation will include spares as specified, and test equipment per the attached listing.

Training is quoted for tuition at the Shawnee Kansas factory for Thales, Incorporated, and covers tuition for one student for the one week course, and does not include air fare, local transportation, per diem or any compensation for the student.

All installation work will be performed by ASMI FAA verified technicians.

Note: The Portable ILS Receiver (PIR) is not included in this quote. This test equipment is provided as part of the Localizer Contract, project number 929-02-0005.

ASMI provides FAA certified maintenance in several FAA regions. 



3. In submitting this Bid, Bidder represents that:
 - (a) Bidder has become thoroughly familiar with the terms and conditions of the proposed Contract Documents accepting the same as sufficient to indicate and convey

understanding of all the conditions and requirements under the Contract that will be executed for the Work.

- (b) Bidder has examined the site and locality where the Work is to be performed, the legal requirements (federal, state and local laws, ordinances, rules and regulations) and the conditions affecting cost, progress or performance of the Work and has made such independent investigations as Bidder deems necessary.





ADOPTED BY THE SHAREHOLDERS OF WESTERN SURETY COMPANY






