By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law, as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 113646 and/or Resolution No. 113647. PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. The purpose of this Addendum is to clarify freight policy and explain basic freight, drop shipping, and cold shipping charges.

Our basic freight policy is based off an orders total when placed. If an orders subtotal is under \$100.00 the freight charge is then \$10.00. If an order is over \$100.00 but under \$300.00 freight is \$5.00. Orders over \$300.00 will have free shipping. In the case that there are products cold shipped and/or drop shipped the below policies will also apply.

We carry certain items that are drop shipped from manufacturers directly to the customer. These items usually have a drop ship freight fee that we receive from the manufacturers on an order to order basis. These charges are calculated by weight and size of the item to the specified shipping location. There will be an indication on the BID if an item is drop shipped.

We also carry specific pharmaceuticals that must be shipped cold (I.E. Vaccines). Items that are labeled as cold ship will have a freight fee added. The cold ship fee will be \$25.00. For every order placed that contains cold ship items, this fee is only applied once and covers all items that are cold shipped per order (purchase order). There will be an indication on the BID if an item is cold shipped.
