Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.

Section 2.0 - Scope:

Bid to cover all removal, preparation, installation, materials, and necessary essentials to install 20 MIL vinyl plank flooring and 6" rubber cove base @ 1855 Ames Blvd., Marrero, LA. 70072.

Section 3.0 - Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. Any measurements given in these specifications are informational only.

Section 4.0 – Bid Specifications

Bidder to supply all labor and materials to perform the following:

Removal of all existing flooring including all carpet, vinyl, tile and laminate in designated areas. Floor prep for Installation of 20-mil vinyl plank flooring w/adhesive. Prep area for installation of 6" rubber cove base. Provide labor and any other essential materials to install vinyl plank flooring with adhesive and installation of 6" rubber cove base.

Section 5.0 – Product Description

20-MIL Vinyl Plank Flooring

Other materials essential to installation and prep.

Section 6.0 – Hours of Work

Work shall be performed during normal working hours. All work must be scheduled with Department of Inspection & Code Enforcement representative 5 days in advance. The successful bidder shall work normal building working hours (8:00am-4:00pm) to provide a safe work environment at no extra charge to Jefferson Parish Department of Inspection & Code.

Section 7.0 - Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish Code Enforcement, and other Parish officials.

Section 8.0 - Existing Structure

Should any cutting, patching, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

Section 9 - Warranty:

All workmanship shall be done not to interfere with the existing warranty in writing, from the manufacturer from the date of acceptance of the projects against defects. The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections, which may be, required to make good all defects in materials and/or equipment under its intended use, within the warranty period, at no cost to the owner.

Section 10 - Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement. The successful bidder shall also be responsible for payment of these permits. All permits, if required must be obtained prior to the start of the project.

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No work shall be performed until the successful bidder is notified by the Department of Inspection & Code Enforcement.


