### **Specifications:**

Build a 17' x 21', wooden deck.

- All lumber will be treated.
- Build it on top of the existing concrete slab using anchor bolts where required
- Extend into the yard with support using 4"x4" pressure treated wooden post cemented in the ground. Minimum 4000 psi allowing enough time to dry (minimum 24 hours on a dry day) before installing deck joists. Posts shall be minimum 2 feet into the ground with 12" diameter of concrete encasing them.
- Deck joists shall be 2" X 6" spaced maximum 16" on center. Joist hangers shall be utilized.
- 5/4 in. X 6 in. pressure treated deck boards shall be used with deck plus star bit ceramic deck screws or equal (2 screws per board per joist).


Provide and install a 16'x20', white, aluminum patio cover.

- Patio support posts shall securely fasten to deck joists.
- Patio shall include down spouts.


