In the event there is a difference in unit prices and totals, the unit prices shall prevail.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. All awards in excess of \$25,000.00 will require both a performance and a payment bond.
