In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. All awards in excess of \$25,000.00 will require both a performance and a payment bond. Unless otherwise stated in the bid specifications, the performance bond requirements shall be 100% of the contract price. ## **Pump Packing Specs**

### **1.0 General**

This shall be for purchase of the following for the Jefferson Parish Eastbank Water Treatment Plant.

(1) one 10 LB roll of .50" Expanded PTFE yarn pump packing (or equivalent)

(1) one 10 LB roll of .625" Expanded PTFE yarn pump packing (or equivalent)

### **2.0 Product Specs**

- Temperature Limit: -29°C – 232°C (-20°F – 450°F)
- Pressure Limit: 22 bar g (325 psig)
- Shaft Speed: 9 m/s (1800 fpm)

Packing must meet FDA requirements 21 CFR 178.3297, 21 CFR 177.2800, 21 CFR 177.1550 and be approved by NSF/ANSI and ACS standards for contact with drinking water

Graphite packing will not be accepted.
