The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes:

**Total Bid Price Must Include the Cost of Naming Jefferson Parish as Additional Insured:**

Bidder acknowledges that Bidder recovered the cost of any required insurance in the contract price as required by La.R.S. 9:2780.1 and that Bidder recovered any such cost for the purposes of insuring an obligation to indemnify Jefferson Parish, defend Jefferson Parish, or hold Jefferson Parish harmless and that Bidder's indemnity liability is limited to the amount of the proceeds that are payable under the insurance policy or policies that Bidder has obtained.

**Electronic Procurement:** Beginning November 1, 2020, Jefferson Parish will no longer accept manual bid submissions; and will only accept bid submissions electronically via our e-Procurement system, Central Bidding. - Laser Grade field for proper drainage and safety
- Jefferson Parish Recreation Department will provide all materials needed for grading
- A skid steer with an automated laser grade attachment and tractor with 8' drag scraper should be used to finish the grade and prepare it for sod installation
- Installation of Sod (in rolls)
  - Celebration Bermuda Sod in 90' length and 42" width will be provided

- All sod netting should be removed during installation process and there should no gaps or overlap in seams (between the rolls) to avoid safety issues

### **Section 3.0 – Bid Specifications:**

Renovation of Owens Playground field for Jefferson Parish Recreation. The field is approximately 220' x 250' or 55,000 sq. ft. The field will need to be laser graded to ensure that the area will drain properly and the field is level and safe to be played on. Jefferson Parish Recreation will provide all materials that will need to be graded and the existing grade will be +/- 2". Upon completion of the laser grading, the field should have a tolerance of within ¼" over 100' and no low spots that will hold water. A skid steer with an automated laser grade attachment should be used to get the grade close to finish grade and a tractor with an 8' drag scraper should be used to finish the grade and leave the area prepared for sod.

Once the grade work is complete, sod should be installed to protect the grade and prevent washout. Certified Celebration Bermuda sod will be provided by JPRD and should be installed in Magnum rolls that are 42" wide and 90' long. Sod is installed in rolls to decrease the number of seams and decrease the amount of time the field takes to establish. Sod should be offloaded from the trucks using a skid steer and staged near the field for installation. The sod should be installed using very lightweight equipment (i.e. KWMI track mounted sod installer). This equipment is to prevent disruption of newly installed sod and reduce the disruption of the finished grade. All plastic netting should be removed from the rolls of sod during install and all seams should be pulled or pushed to prevent any gaps in between

the rolls of sod or overlap. All tubes in the sod rolls, plastic netting, and any debris should be disposed of and removed offsite.

#### **Section 4.0 – Hours of Work:**

Work shall be performed during normal working hours. All work must be scheduled with owner representative in advance.

#### **Section 5.0 – Cleaning Area and Safety:**

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

#### **Section 6.0 – Existing Structure:**

Should any cutting, patching, alteration, addition, or repairs to existing field, structure, wall, floor, ceiling or part of building be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish and workmanship.



### **Section 7.0 – SDS (Safety Data Sheets):**

The bidder shall notify the Jefferson Parish Department of Recreation contact person of any hazardous substances that will be bought to and/or used at the workplace.
