

On motion of **Mr. Walker**, second by **Mr. Templet**, the following resolution was offered:

**RESOLUTION NO. 135550**

A resolution accepting the lowest responsible bid from Progressive Solutions, LLC, under Bid Proposal No. 50-00129735 for a two (2) year contract for supply of herbicides, labor, and equipment to control weeds and undesired vegetation on drainage canals, ditches, and servitudes on the East and West Bank of Jefferson Parish for the Department of Drainage. Expenditures shall not exceed \$2,500,000 for the two (2) year contract period and compensation shall not exceed this amount by a factor of more than 10% without amendment to the contract authorized by the resolution of the Council (Parishwide)

**WHEREAS**, there were two (2) bids received for Proposal No. 50-00129735; and

**WHEREAS**, Progressive Solutions, LLC submitted the lowest responsible bid in the amount of \$2,110,497.54 on all individual bid items and the lowest responsible bid overall.

**WHEREAS**, the totaled expenditure to date is \$1,103,223.00 for the current contract with Progressive Solutions, LLC from January 25, 2018 to present; and

**WHEREAS**, the current contract shall expire on January 24, 2020, and whereas, maximum expenditures shall not exceed two years for the for a two (2) year contract for supply of herbicides, labor, and equipment to control weeds and undesired vegetation on drainage canals, ditches, and servitudes on the East and West Bank of Jefferson Parish for the Department of Drainage.

**NOW, THEREFORE, BE IT RESOLVED** by the Jefferson Parish Council, Jefferson Parish, acting as governing authority of said parish:

**SECTION I:** That the lowest responsible bid under Proposal No. 50-00129735 from Progressive Solutions, LLC for a two (2) year contract for supply of herbicides, labor, and equipment to control weeds and undesired vegetation on drainage canals, ditches, and servitudes on the East and West Bank of Jefferson Parish for the Department of Drainage at the bid tabulation price of \$2,110,497.54, is hereby accepted.

**SECTION II:** That expenditures are to be charged to Account Numbers 22320-3301-316-7347.4 and 22320-3302-316-7347.4.

**SECTION III:** That the maximum total expenditures should not exceed \$2,500,000.00 for the two years by a factor of not more than ten percent (10%) without amendment to the contract authorized by resolution of the Council.


**SECTION IV:** That the Chairperson of the Jefferson Parish Council, or in his or her absence the Vice-Chairperson, be and is hereby authorized to execute any and all documents necessary to give full force and effect to this resolution.
