## Dimension Diagram

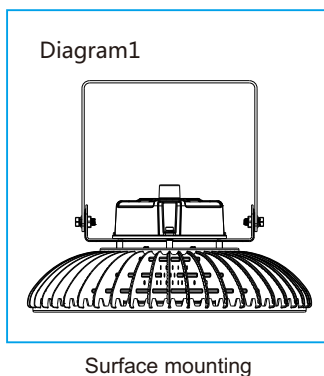

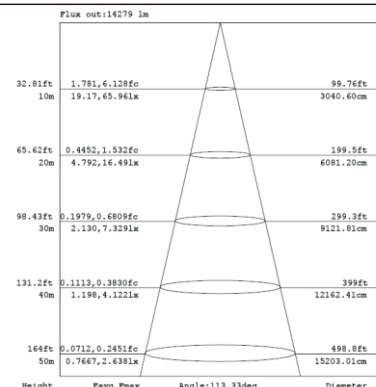
