

On motion of **Mr. Roberts**, seconded by **Ms. Lee-Sheng**, the following resolution was offered:

**RESOLUTION NO. 132009**

A resolution accepting the lowest responsible bid of **Fleming Construction Company, LLC** received on July 31, 2018 under Proposal No. 50-123141 in the amount of \$1,094,935.20 for Canal No. 10 Drainage Improvements at W. Esplanade Ave., Public Works Project No. 2011-029-DR (Council District 4).

**WHEREAS**, Jefferson Parish received bids on July 31, 2018 for the construction of Canal No. 10 Drainage Improvements at W. Esplanade Ave., Public Works Project No. 2011-029-DR; and

**WHEREAS**, Fleming Construction Company, LLC submitted the lowest responsible bid under Proposal No. 50-123141 in the amount of \$1,094,935.20; and

**WHEREAS**, the engineer, All South Consulting Engineers, LLC, has reviewed the bids and has recommended that award of contract be made to Fleming Construction Company, LLC; and

**WHEREAS**, the project is being funded with local funds and those funds are in place and are sufficient to construct the project.

**NOW, THEREFORE, BE IT RESOLVED**, by the Parish Council of Jefferson Parish, Louisiana, acting as governing authority of said Parish:

**SECTION 1.** That the lowest responsible bid received from Fleming Construction Company, LLC on July 31, 2018 under Proposal No. 50-123141 in the amount of \$1,094,935.20 for Canal No. 10 Drainage Improvements at W. Esplanade Ave., Public Works Project No. 2011-029-DR, is hereby accepted.

**SECTION 2.** That the Chairperson of the Jefferson Parish Council, or in his or her absence the Vice-Chairperson, be and they are hereby authorized, empowered, and directed to sign and execute a contract with Fleming Construction Company, LLC, which contract shall include the bid proposal, plans and specifications for said project.

**SECTION 3.** That all work related to the construction of Canal No. 10 Drainage Improvements at W. Esplanade Ave. is to be charged to Account No. 45230-4039-7454 (52356.027).

**SECTION 4.** That the term of this contract shall commence on the date indicated on the Notice To Proceed.
