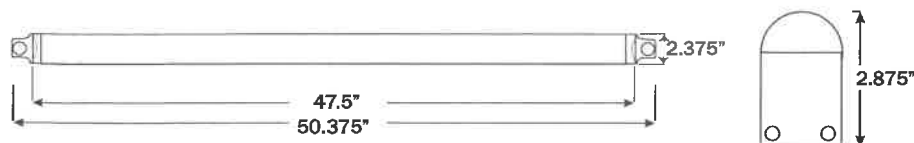

THE LED-4 SERIES 10 YEAR LIMITED WARRANTY

The limited warranty set forth below is given by _____, ("Seller") with respect to the lighting product packaged with this limited warranty (the "Product"). The Product, when delivered in new condition in its original packaging, is warranted against defects in materials or workmanship for a period of TEN (10) YEARS from the date of original purchase. This is a prorated warranty. For years ONE (1) through FIVE (5), defective parts or a defective Product returned to Seller, and proven to be defective upon inspection, will be repaired, or exchanged for a replacement part or a new Product, as determined by Seller. For years SIX (6) through TEN (10) a prorated credit will be provided to be used towards the purchase of a replacement

fixture. The proration is as follows: Year SIX (6) Eighty Percent (80%) of the price will be credited; Year SEVEN (7) Sixty Percent (60%) of the price will be credited. Year EIGHT (8) Forty Percent (40%) of the price will be credited; Year NINE (9) Twenty Percent (20%) of the price will be credited; Year TEN (10) Ten Percent (10%) of the price will be credited. This limited warranty covers all defects encountered in normal use of the Product, and does not apply in the following cases: Loss of or damage to the Product due to acts of God; fire; vandalism; civil disturbances; power surges; improper power supply; electrical current fluctuations; corrosive environment installations; abuse; alteration; accident; mishandling; failure to follow operating, maintenance or environmental instructions prescribed by Seller in writing or services performed by someone other than Seller. Warranty is void if product is not used for the purpose for which this product is manufactured.

Seller shall have no liability under this warranty unless Seller is notified in writing within thirty (30) days after your discovery of the defect. Upon review _____ will authorize an RGA that may require Buyer to return the material freight prepaid to the Seller.
