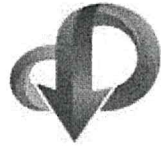

SECTION 2.0-SCOPE:

Fire alarm inspection, maintenance and monitoring for the Jefferson Parish Department of Public Works - Streets Department for locations listed below for a two (2) year period.

- 1901 Ames Blvd., Marrero, LA
- 200 Shrewsbury Road, Jefferson, LA

Bids shall be on an Edwards I/O 1000 System located at 1901 Ames Blvd., Marrero, LA and an Edwards I/O 500 System located at 200 Shrewsbury Road, Jefferson, LA.

Customer agrees to allow vendor's employees access to all areas that contain fire alarm system devices for the sole purpose of performing the services hereunder.

Inspection:

All testing and inspection procedures performed by vendor will be commensurate with the guidelines and specifications set for by NFPA 72 and/or the Louisiana State Fire Marshall. Upon completion, vendor will issue a NFPA report listing the equipment tested and the results of the test. Vendor will perform one inspection per this contract annually. Vendor will issue the appropriate State of Louisiana Fire Marshall tag upon completion for the prescribed fee.

Maintenance:

Vendor will preserve the operational integrity of the fire alarm system including parts, labor and service calls for the prescribed fee.

Monitoring:

Vendor will provide a digital alarm communicator transmitter (DACT) and monitoring services in order to transmit alarms and trouble to the vendor's remote central station service provider for the prescribed fee.

Services to be performed:

- 1) One complete annual test and inspection in accordance with Louisiana State Fire Marshall and issuing of the test and inspection report to customer upon completion.
- 2) Smoke detector sensitivity testing will be conducted by the vendor only if sensitivity testing was not conducted on customer's system the prior year. In the case of a multi-year contract, sensitivity testing will be conducted again on alternate years.
- 3) Maintain full operation of fire system. In the event of system failure, the vendor will identify the problem(s), repair or replace the defective component(s) and supply labor for same at no cost to customer.
- 4) Labor, parts (excluding batteries and smoke detector replacement) and travel charges will be waived for all service related work. 24/7 coverage is in effect for this contract.

SECTION 3.0-LIMITS OF COVERAGE

Fire Alarm System:

SECTION 4.0-DURATION & RENEWAL

Proof of their qualifications as Factory Authorization and Factory Training for the products specified herein. The bidder shall have the ability to download all system application programs and firmware from a computer. If any of the equipment provided under this specification is provided by different manufacturers, then that equipment shall be recognized as compatible by both manufacturers, and listed, as such by Underwriters Laboratories.




