The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. ELEVATOR MAINTENANCE SERVICES SPECIFICATIONS

1. Scope

- a. The work to be performed by the Contractor consists of furnishing all material, labor, supervision, tools, supplies, and equipment necessary to provide full maintenance service, including all inspections, adjustments, tests, parts or component replacements, and repairs to keep the elevator in continuous use at its established capacity and efficiency. Machinery and equipment shall be maintained in compliance with the latest American National Safety Code for Elevators and Escalators (ANSI A17.1 and A17.2), and terms and conditions of this contract.

2. Location to Be Serviced

- a. Alario Center – 2000 Segnette Boulevard – One Elevator, 2000lb Capacity

3. Contractor Responsibilities

- a. The scheduling, frequency, and performance of the maintenance service procedures specified shall be carried out in accordance with established industry procedures.
- b. The elevator shall be examined and maintained once per month.
- c. Contractor shall furnish a qualified elevator mechanic on the job-site for performance of examinations and preventative maintenance. Said elevator mechanic shall provide preventative maintenance at the job site for a minimum of one (1) hour per inspection. Said mechanic will check in at a designated location when he arrives and when he leaves the building.
- d. Contractor will:
 - i. Keep guide rails properly lubricated, except where roller guides are used.
 - ii. Replace guide shoe gibs or rollers, when conditions warrant, to provide quiet operation.
 - iii. Repair or replace control cables, when conditions warrant.
 - iv. Periodically drain the gear case, flushing to remove sediment and grit, and refill with new gear oil.
 - v. Relamp all signals.
 - vi. Furnish lubricants that meet the equipment manufacturer's specifications.
 - vii. Periodically examine, clean, lubricate, adjust, and when conditions warrant, repair or replace the following safety devices.
 - 1. Interlocks and door closers
 - 2. Car and counterweight buffers
 - 3. Over speed governors, governor tension sheave assemblies and car counterweight safeties
 - 4. Limit, landing, and slowdown switches
 - 5. Door protective devices and alarm bells
 - viii. Conduct a yearly no-load, low speed test of car and counterweight safeties and a test of buffers

- ix. Periodically equalize the tension in all hoist way ropes. Replace all wire ropes and fastenings when conditions warrant
 - x. Examine and, when conditions warrant, re-groove or replace all sheaves, governor tension sheaves, secondary or deflection sheaves and compensating sheaves
 - xi. Periodically examine, lubricate, adjust, and, when conditions warrant through normal wear and tear, repair or replace the following accessory equipment:
 - 1. Car and corridor operating pushbuttons
 - 2. Load weighting equipment
 - 3. All hall lanterns, car position and hall position indicators, lobby control panels, car operating panels, and all other signal and accessory facilities furnished and installed as part of the whole equipment
 - xii. Periodically clean all elevator machine rooms, secondary areas, elevator hoist ways, and pit areas. The Contractor will be responsible for keeping the machine rooms, the exterior of the machinery, and any other parts of the equipment subject to rust properly painted, identified, and presentable.
 - xiii. Annually clean the elevator hoist way and related equipment, including rails, inductors, hoist way door hangers and tracks, relating devices, switches, buffers, car tops and pit areas.
 - xiv. Test the car and counterweight safeties, governors, buffers, and all other safety devices.
 - e. Written reports of all tests are to be made available within thirty (30) days following completion and will be made available for review upon request.
- 4. Hours of Service**
- a. The Contractor shall perform all work, except emergency minor adjustment call back service, during regular working hours and regular working days.
 - b. Emergency call-back, at any time of day, should be responded to within two (2) hours.
- 5. Inventory**
- a. The Contractor shall own and maintain a sufficient amount of replacement parts by the original manufacturer, or approved equal, to maintain the equipment in a first class and safe operating condition. These parts shall be made available to the Alario Center for inspection if so requested. Upon award, the Contractor will submit a list of parts to be included in the inventory. This list will be maintained by the Alario Center in order to gauge performance and responsiveness.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. 
