Section 1.0 – Pre-Bid Conference:

There will be no pre-bid conference for this bid. All prospective bidders are encouraged to visit the site prior to submitting a bid.

Section 2.0 – Scope:

We extend this bid to cover all labor, materials, freight and necessary essentials to provide and install one (1) new, Double-Sided, polystyrene monument style sign, as per the associated plans, located within the center median of Lapalco Boulevard near the intersection of Bannerwood Drive in Gretna, Louisiana.

Section 4.0 – Existing Site:

Jefferson Parish shall field determine the exact location of the proposed sign. Minor grading and site dressing may be required to ensure the area is returned to its preconstruction condition.

The Contractor is responsible for getting all existing utilities marked prior to construction.

The Contractor shall not be responsible for acquiring a DOTD permit for this project.

No landscape or electrical work is included with this bid.

Section 5.0 – Bid Specifications:

- Provide and install one (1) new Double-Sided polystyrene monument style sign in accordance with the associated plans.
- The Contractor shall be required to provide submittals on the polystyrene sign to the Jefferson Parish Parkways Department for approval prior to ordering the sign.
- No electrical work is included in this bid.
- No permits shall be required by the Contractor.
- The Contractor shall be responsible to return the site to its original condition once work is complete.

Section 6.0 - Hours of Work:

Work shall be performed during non-holiday weekdays between the hours of 8:00 am and 4:00 pm. The Contractor shall provide the Jefferson Parish Parkways Department with a minimum twenty-four (24) notice prior to the start of work. Once the installation is complete, the Contractor shall contact the Jefferson Parish Parkways Department to schedule a final inspection of the work.

Section 7.0 – Cleaning Area and Safety:

The job site must be clean and free of all litter and debris daily and upon completion of the contract. The Contractor shall fence off his work when he is not on site working. Equipment and material storage shall not be permitted on site. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 8.0 – Warranty:

The Contractor shall warrant his materials and workmanship for a period of one (1) year after final acceptance of the project.


Section 9.0 – Pre-Construction Conference and Notice to Proceed:






① VICINITY MAP





All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

Property Damage Liability \$1,000,000.00 each occurrence.

Note: This category may be omitted if bidders do not/will not utilize company vehicles for the project or do not possess company vehicles. Bidder must request an automobile insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. DEDUCTIBLES - The Parish Attorney with concurrence of the Director of Risk Management have waived the deductible section of the Terms and Conditions for all Invitations to Bid, until further notice.

UMBRELLA LIABILITY COVERAGE

An umbrella policy or excess may be used to meet minimum requirements.

FOR CONSTRUCTION AND RENOVATION PROJECTS:

The following are required if selected below. Such insurance is due upon contract execution.

OWNER'S PROTECTIVE LIABILITY

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

BUILDER'S RISK INSURANCE

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
