I am bidding for you to use Merck products. Merck products can be ordered through Merck directly or through every major distributor. The only product that must be ordered through Merck is the \$5 Home Again microchips.

The total price of all bid items is high because I believe the quantity of 3,000 Panacur is listed incorrectly. I still calculated on that amount. To bring the price down, I calculated Bravecto as individual units, not cartons of 10. I attached the pricing of all our vaccines, Bravecto, Sentinel and Tri-Heart to this bid so you can see all the items you can order through the distributor and their prices. I also highlighted the vaccines you have bought from us. Lastly, Activyl is discontinued. I recommend we discuss using a special program of \$10 Dog Topical Bravecto to replace it. That will be ordered directly from Merck and cannot be ordered through the distributor.

I only included the pages of the bid that Merck has products to bid on.

Merck pricing agreements last until February 28, 2022. I cannot change the pricing change date; however, the price increase is flexible.

Merck does not charge shipping.






