

On motion of **Mr. Impastato**, seconded by **Ms. Lee-Sheng**, the following resolution was offered:

**RESOLUTION NO. 131665**

A resolution accepting the lowest responsible bid of **Beacon Air Conditioning, Heating and Refrigeration, Inc.**, bid under Bid No. 50-122664, in the amount of One Hundred Four Thousand Four Hundred Seventy-Seven Dollars (\$104,477.00) for labor, materials, and equipment necessary to remove and properly dispose of ten (10) existing direct expansion (DX) air cooled condensing units and provide and install ten (10) new direct expansion (DX) air cooled condensing units with electric heat strips, located at the Salvador Liberto Building, 802 2<sup>nd</sup> Street, Gretna, LA, for the Department of General Services. (Council District 1)

**WHEREAS**, bids were received on May 17, 2018; and

**WHEREAS**, Beacon Air Conditioning, Heating and Refrigeration, Inc., was the lowest responsible bidder; and

**WHEREAS**, existing equipment is approaching its life span of operations; and

**WHEREAS**, the current air conditioning equipment has been determined to be inefficient; and

**WHEREAS**, new air conditioning equipment will greatly reduce the risk of facility down time due to air condition failure.

**NOW, THEREFORE, BE IT RESOLVED** by the Jefferson Parish Council of Jefferson Parish, Louisiana, acting as governing authority of said Parish:

**SECTION 1.** That the lowest responsible bid of Beacon Air Conditioning, Heating and Refrigeration, Inc., bid under Bid No. 50-122664, in the amount of One Hundred Four Thousand Four Hundred Seventy-Seven Dollars (\$104,477.00) for labor, materials, and equipment necessary to remove and properly dispose of (10) existing direct expansion (DX) air cooled condensing units and provide and install ten (10) new direct expansion (DX) air cooled condensing units with electric heat strips, located at the Salvador Liberto Building, 802 2<sup>nd</sup> Street, Gretna, LA, for the Department of General Services, be and is hereby accepted.

**SECTION 2.** That the Chairperson of the Jefferson Parish Council, or in their absence, the Vice-Chairperson, be and is hereby authorized, empowered, and directed to sign and execute a contract and all related documents with Beacon Air Conditioning, Heating and Refrigeration, Inc.

**SECTION 3.** That all expenditures incurred shall be charged to Account No. 10010-0065-114-7431.2.
