The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. 1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner.

PART 1 GENERAL

1.01 DESCRIPTION

- A. SCOPE: This section specifies peristaltic hose pump, complete with electric motor, wall mounted VFD controller. Pump and motor shall be mounted on a common mounting frame.
- B. TYPE: The pumping units shall be of the self-priming, positive displacement, peristaltic type specifically designed for pumping powdered activated carbon in slurry form (PAC).
- C. EQUIPMENT LIST

One (1) Jesco Peridos FS series peristaltic pump or equivalent.
- D. PERFORMANCE AND DESIGN REQUIREMENTS:
 - 1. PAC pump shall be specifically designed and selected for continuous duty pumping of liquids with the following properties:

PART 2 PRODUCTS

2.01 ACCEPTABLE PRODUCTS

- A. ONE (1) – Horizontal Peristaltic pump Jesco Peridos FS series pump or equivalent.

2.02 EQUIPMENT

- A. ANSI Class 150# flanges, SS inserts. Hose shall be natural rubber fiber braided. Corrosion Resistant Coating shall be primary and final polyurethane acrylic epoxy body and rotor. Cast iron mounting frame, stamped galvanized steel process connection inserts. 316 stainless steel hardware, gearbox inlet 1800 and outlet

75 RPM. Driven by a 2 H.P. motor, 230/460/3/60 inverter duty and include remote wall mounted /VFD with display and keypad. Selectable manual or automatic control via 4-20 mA input signal, 230/3/60, NEMA 4X. Pump shall include rupture hose detection.

- B. A spare hose for the FS32- natural rubber fiber braided with white stripes shall be provided.

PART 3 EXECUTION

3.01 INSTALLATION

- A. The pump shall be installed by Jefferson Parish. These are existing pumps that will be replaced into existing PAC piping.

4.01 Service

The pump bidder must be listed as a factory authorized service center for the brand they are bidding and be capable of completely servicing the proposed pumps within one (1) hour of the project site. The pump bidder must have a direct factory service center and stocking facility capable of completely servicing and supplying spare parts for the proposed pumps within one (1) hour of the project site. The bidder's service center must have full time, factory trained mechanics certified to service the equipment being offered.

5.01 Warranty

The pump unit or any parts thereof shall be warranted against defects in material or workmanship within one year from date of installation and shall be replaced at no charge with a new or manufactured part, F.O.B factory or authorized warranty service center.
