1.0 SCOPE OF WORK

Provide uniformed security and/or armed guards for the John A Alario, Sr. Event Center on the dates and times as requested by the General Manager of the Alario Center or its authorized representative. The Alario Center shall provide a minimum of twenty-four

(24) hours advance notice requesting event security and/or armed guards; however, proposer must be able to provide additional personnel on an emergency basis - within one (1) to two (2) hours - at the same hourly quoted rate.

Provide an in-house, 24-hour, 7-day per week contact name and telephone number for a supervisor. Answering services are not acceptable.

Provide uniform attire, including weather attire for use during inclement weather conditions. Flashlights shall be provided as part of the uniform.

Supply personnel that are physically, mentally and emotionally qualified to perform the requirements as specified.

Responsible for the conduct of its employees to ensure it is acceptable and prevents the use of general rudeness, profanity or undue force, and for being offensive or disrespectful to Alario Center guests or staff.

Duties:

Staff specific locations to screen patrons and allow entry at access points by operating walk-through and/or handheld magnetometers.

Serve as bag checkers to prevent restricted or prohibited items, contraband, weapons, etc. from entering the facility.

Enforce building policies and procedures.

Assist in crowd control management during the screening and checking process.

Take prompt action against unauthorized persons, illegal entry and/or contraband.

Assist with patron safety and customer service.

Observe and report any criminal offenses, violations of policies, procedures, rules and regulations.

Become familiar with and adhere to the facility's sign-in/out procedures, employee entrances, building policies, who and where to report for work and who to contact for any dispute resolution.

Attire, Appearance and Demeanor:

Employees shall be properly attired at all times in a uniform that is neat, clean and in good repair. Uniforms shall include a patch or emblem depicting Proposer's business name and a name tag and photo I.D. of the employee.

Personnel must be neat, clean and courteous while on duty.

Cell phone use is not permitted while on duty.

Meals and snacks shall be taken in private and not at an assigned post.

Smoking, including electronic tobacco products, is NOT allowed.

All personnel should demonstrate effective customer service skills.

Security and/or armed personnel shall cooperate fully with all local, state and federal law enforcement agencies.

The Alario Center reserves the right to require the immediate removal of any employee from their post if they are deemed unfit for any reason or found to be in violation of any of the criteria established in this bid.

2.0 QUALIFICATIONS AND EXPERIENCE

A minimum of one (1) year of event staffing and/or security experience

A high school diploma or GED.

Physical fitness necessary to perform various security functions as assigned and adequate health required to physically perform job duties.
