Two year contract for a supply of Concrete Storm Drain Culverts for the Jefferson Parish Department of Public Works – Drainage & All Jefferson Parish Agencies.

These specifications are prepared for a two (2) year supply of concrete storm drain culverts and related items used by the Department of Public Works for all drainage districts, east and west banks.

Vendor is requested to quote a written lump sum price for furnishing all quantities as hereon listed.

The delivery time for each purchase order shall not exceed thirty (30) calendar days. In the case that the vendor needs additional time for delivery, a written request to the Jefferson Parish Department of Public Works shall be required.

Vendor is to include all matter of his cost from inception of order to the site delivered and shall include and reflect same as part of his unit cost per foot bid quote.

#### SPECIFICATIONS

##### Reinforced Concrete Pipe

Reinforced Concrete Pipe for use as sewers shall conform to the latest current specifications of the A.S.T.M for reinforced concrete culvert, storm drain, and sewer pipe, designation C-76.

##### Reinforced Concrete Arch Pipe

Reinforced Concrete Arch Pipe shall conform to the latest current specifications of the ASTM for reinforced concrete arch culvert, storm drain, and sewer pipe designation C-76.

##### Rubber Gasket Joints

Rubber Gasket Joints shall conform to the latest specifications of the ASTM C-443 for joints for circular concrete sewer and culvert pipe using flexible watertight, rubber-type gaskets.

##### Specifications for precast concrete channel sections

Precast concrete channel sections shall be 10ft. wide with 4ft. high side walls and shall be designed to withstand side loads and moments in the side walls generated by equivalent HS-20 loading conditions. Each section shall have two 2in. diameter weep holes.

The joints shall be tongue and groove with a minimum 6in. depth, a maximum annular space of ½ inch and a maximum taper of 10 degrees. Ram-Nek joint material shall be included in the price bid per foot.

All sections shall be manufactured with four banding holes, one on each side at both ends of the section. These holes shall be approximately 15in. from the base of the section.

These pre-cast concrete channel sections are to be designed and used for the following applications.

1. As a ditch liner with earthen side slopes and HS-20 live loads parallel to the section. The maximum allowable depth from top of ground to top of channel wall is 10 feet.
2. As a ditch liner with a flat slab (pre-cast or poured in place) spanning the section keyed into each wall and HS-20 live loads parallel to the section. The maximum allowable cover on the slab is 10 feet.
3. As a 10FTx9FT box section made by inverting a second section over the first with a maximum cover of 10 feet and HS-20 live loads parallel to the sections. Paving is included in the maximum depth.

Specifications for Precast Concrete Box Culverts

Box culverts shall conform to the latest current revision of the ASTM specification C789 for precast reinforced concrete box sections for culverts, storm drains and sewers. The manufacturer must furnish a certificate that the box culverts do conform thereto and that it has been tested according to the ASTM specifications by a testing laboratory. The cost of all inspection and testing must be included in the prices bid for box culverts.

The joints shall be tongue and groove. Ram-Nek joint material shall be included in the price bid per foot for box culverts.

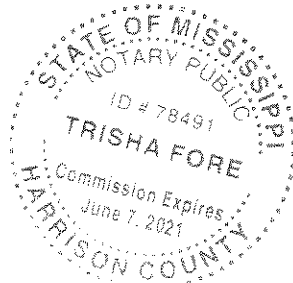

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the advertised bid. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.
