1. GENERAL:

The vendor shall quote on supplying three (3) Invent Model ITB750-10, or approved equal, Turbo Blowers with acoustic enclosures. This specification is issued for the supply of Compact High Speed Turbo Blowers for the Bridge City WWTP, Jefferson Parish, LA aeration system. Supply 3 blowers as specified below with the following: inlet filters and blow off system, 8" epoxy coated discharge silencer, 8" 316 SS discharge RSK check valve, 8" 304 SS discharge expansion joint with MS flanges, 75HP motor, 460/3/60, maximum flow of 1500 scfm, pressure 6.0-13 PSI. Bid shall include one set of spare parts which are ITURBO filters. The supply includes for all design, manufacture, testing and supply of the items as defined in the "Scope of Supply".

2. SCOPE OF SUPPLY:

Each blower shall be a "UL Certified" integrated blower package within an acoustic enclosure and include, but not limited to the following components & activities, or approved equal:

- High Speed Permanent Magnet Synchronous Motor (PMSM) with oil free bearings ridged collar air cushion bearings only.
- 5 axis machined Aluminum alloy centrifugal impeller mounted directly to the motor shaft without a gearbox.
- Yaskawa VFD to drive PMSM motor
- Rockwell / Allen Bradley Industrial PLC control systems.
- Rockwell /Allen Bradley Color Touch Screen HMI.
- Emergency Stop with full current isolation to MCCB.
- Integrated Inlet air filter system/silencer
- Blow Off / Unloading valve and controls.

- Discharge flexible connection.
- Discharge Check Valve.
- Discharge Silencer.
- Design & Drawing submittals.
- Factory Acceptance Testing (FAT)
- Delivery to Site
- Site Acceptance Testing/Commissioning.

All equipment specified in this section shall be designed and furnished by the blower manufacturer, who shall be responsible for the suitability and compatibility of operation, and all statutory safety and environmental regulations. Only equipment manufacturers that have direct representation within the United States of America specifically Louisiana shall be considered.

Any bids submitted for blowers other than that as specified, must include in their bid all information needed to fully demonstrate complete compliance with requirements of these specifications. The bid will be awarded to the lowest responsible bidder complying with all provisions of this invitation, providing the bid is reasonable, and in the best interest of Jefferson Parish to accept. Jefferson Parish reserves the right to accept or reject the bid in whole or part, any bids that are incomplete or do not demonstrate that they are equal to the requirements of these specifications. It is the bidder's responsibility to provide adequate information necessary for the complete evaluation of their proposed equipment. Jefferson Parish shall be the sole judge as to the equality of any manufacture's offering.

Exclusions

The following activities are excluded for the Scope of supply and are to be provided by the Parish installation contactor.

Unloading of the delivery at site.

Installation of the blowers and interconnecting pipework.

Power and control cabling to the blowers.

3. Blower Performance requirements:

Site Data:

The blowers shall be located in an enclosed purpose-built blower house the available power supply is 460-480V 60Hz.

The 3-sided shelter will be modified to add a lip on the open side. The air filter side of the blower will be placed to face the closed side of the blower shelter.

Site Elevation = 0 ft AMSL (Above Mean Sea Level)

Maximum Temperature/RH = 100°F / 80% RH

Minimum Temperature/RH = 20°F / 36% RH

All equipment, including controls and drives shall be designed to operate in this environment.

Performance Requirements:

Airflows specified in this document the total airflow required by the aeration system. The number of blowers (3) shall be verified by the blower manufacturer based on achieving maximum efficiency and the lowest life cycle cost (LCC).

The blower performance boundary shall be as defined in the “Wire to Air Performance Test Code ASME PTC 13 2018” All airflows stated shall be Delivered Airflow (outlet air flow), not inlet airflow.

The yearly power consumption shall be determined by the following distribution:

8760 hours per year.

15% (1314) hours operating at Maximum Design Condition.

60% (5256) hours operating at Average Design Condition.

25% (2190) hours operating at Minimum Design Condition

4. Blower Design:

The blower shall be high speed centrifugal design, with a single motor a direct driven turbo fan in ridged collar air cushion bearings. Turbo blowers with thin "flexible foil" type air bearings are not permitted.

The blower package with acoustic enclosure shall include all components for safe and reliable operation. The enclosure and all associated panels shall be electrostatically powder coated and baked to ensure durable surface protection.

All fasteners and fixings on or within the blower package shall be 316 Stainless Steel.

Approved manufacturer is Invent iTurbo, or approved equal. The blower model shall be specifically UL certified for operating in the United States of America.

The blower shall have a combined inlet filter/silencer array that can be serviced by a hinged door to allow the replacement of inlet air filters. The filter must be a dual filtration system with a course prefilter of ASHRAE MERV 1 (EN779 G1/G2 or equivalent) followed by a medium filter of ASHRAE MERV 6-8 (EN779 M5 or equivalent).

The blower enclosure shall have separate and individually accessible compartments for the power components, the control system & the main circuit breaker. All compartments shall have access only using an electrician key, except for the filter panel access door. The blower enclosure shall also act as an acoustic cover limiting the sound pressure level to <78dBA. Additional silencers may be used to ensure the attenuation limits are not exceeded.

Each blower package shall have a 304 Stainless Steel flexible connector located at the inlet and the discharge of the package. The flexible connectors shall be sized for a standard pipe diameter and shall prevent the transmission of noise and vibrations from the blower package into the piping. The expansion joint shall be suitable for the maximum operating temperature and pressure ratings of the equipment in the air stream. Provide stainless restraining bolts and hardware.

Each blower shall be supplied with a "Duo" check valve that shall be installed on the discharge line manufactured from a Cast Steel body with 304 Stainless Steel internals and "Viton" PTFE seats and seals.

Each blower shall be supplied with an epoxy coated "absorptive" discharge silencer, sized for a maximum internal air flow velocity of 20m/s (65 ft/s) with a minimum overall length of 5 feet or 1500mm.

The control system shall be Allen Bradley PLCs, or approved equal. Another 3rd party micro-controller-based system shall not be used. All communication and control of the blower shall be "Ethernet IP" communications.

The Blower shall have, as a minimum, the following monitoring sensors and/or diagnostic capability.

- Air Inlet & Discharge Temperature. (°F)
- Air Discharge Pressure. (psi)
- Pressure Ratio

- Air Filter Differential Pressure. (psi)
- Air flow Rate. (Scfm)
- Operating Speed. (rpm)
- Power consumption. (hp/kW)
- Motor temperature. (°F)
- VFD Temperature. (°F)
- Run Hours.
- Start Counter.
- Blower Set Value Feedback.
- Alarm Status.
- Fault Status.
- Ready Status
- Unloaded Status.
- Loaded Status

The blower package shall have an integrated “Blow-Off” / “Unloading” Valve where-by all control and activation is by the blower PLC. “Blow-Off” / “Unloading” Valves that require any external inputs or separate power supplies shall not be used. Turbo blowers with thin “flexible foil” type air bearings are not permitted.

The blower operator interface shall be a touch screen HMI of minimum 7” screen size. Mechanical push buttons for starting/stopping and Emergency stop shall also be included. “Virtual” HMI buttons for manual “starting” and/or “stopping” the blowers shall not be used.

The “Emergency Stop” shall offer full current isolation of the complete blower package by tripping the blower circuit breaker if pushed and be considered as normal operating procedure without damage to the blower.

5. Execution:

Factory Testing

All blower packages shall be factory tested in accordance with the “Wire to Air Performance Test Code ASME PTC 13 2018” prior to delivery as follows.

At each duty point as stated in the “Performance Schedule” to confirm the guaranteed power consumption.

Each Max and Min Flow corresponding to the design header pressure as stated “Performance Schedule” to ensure guaranteed turndown.

Field Commissioning & Site Representation

The service of a qualified representative of the manufacturer shall be provided to inspect the installation of the equipment, make any necessary adjustments, test and place

the equipment in satisfactory operating condition.

After installation of all plant equipment has been completed and as soon as conditions permit, the manufacturer shall provide as a minimum one (1) trip for two 2 x 8-hour days to conduct an acceptance test under actual operating conditions, to determine the operation is satisfactory and free from excessive vibration as defined by the blower manufacturer. The test shall consist of 3 hours' operation of each blower with readings taken and recorded as directed by the manufacturer.

Operator Training

The manufacturer shall provide one (1) trip one 8-hour day for the purposes of "Training" the Owners operators immediately after the blowers have been placed into operation. This visit shall be coordinated with the Owner. There is no "LABOR" required for this bid.

6. Submittals:

The following submittals shall be provided by the blower manufacturer:

- Predicted performance curves developed for the specific application. Performance curves shall show speed, capacity, horsepower and efficiency, over the manufacturer's recommended range of operation.
- Detail drawings & weights for each Blower including flexible connection, Check valve and silencer.
- Electrical & Control Wiring Diagrams for each Blower.
- Communications and Control map. (ie Ethernet Tags)
- Descriptive brochures and blower data.
- Operation and Maintenance Manuals
- List of 5 years recommended spare parts for five (5) years operation.
- Complete Packing List of all components and equipment supplied.
- Manufacturers ASME PTC-13 performance test results.

7. Warranty:

Manufacturer shall provide their standard manufacturer's warranty.

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated and/or supporting documentation supplied with bid submission.






