1. The reinforced concrete box culvert Typical Section detail "D" on Plan Sheet CD-4, #57 limestone or #57 crushed concrete is utilized as the side bedding. Would #57 limestone or #57 crushed concrete which has similar gradation to the "lightweight aggregate" (expanded shale) be accepted as an approved equal for the 3' feet bedding material?

***No, #57 stone cannot be used instead of lightweight aggregate. The lightweight aggregate is specified to reduce the overall load on the foundation soil to mitigate subsidence of the box. No. 57 stone is almost three times as heavy as the lightweight fill.***

2. Will we be allowed to use trench boxes for shoring on this job?

***Yes. This falls under means and methods, for which the Contractor is responsible. Maintaining the safety of the trench at all times is the responsibility of the contractor, regardless of how he chooses to construct the project.***

3. Sheet C0-4, Note #2: "Remove dirt, muck, and other soft material to a depth necessary to establish a firm foundation." Per Note #1 on the same page, the 57 stone and lightweight aggregates are included in the price of the box, and there is no separate pay item for the stone and lightweight aggregate. Due to the inability to predict how much excavation will be needed to get to a firm foundation, would you consider creating separate pay items for the stone and lightweight aggregate and remove those materials from the box pay item?

***The stone and lightweight aggregate are to remain included in the cost of the box culvert.***

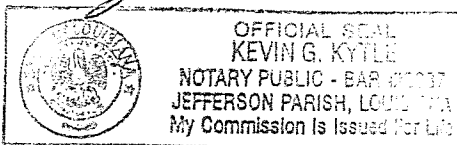

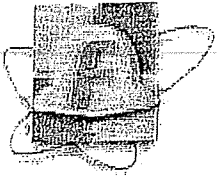

**General Instructions**

Section references are to the Internal Revenue Code unless otherwise noted.

**Purpose of Form**

A person who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) to report, for example, income paid to you, real estate transactions, mortgage interest you paid, acquisition or abandonment of secured property, cancellation of debt, or contributions you made to an IRA.
