## **THREE (3) YEAR CONTRACT TO FURNISH ONE (1) 1250 KW PORTABLE EMERGENCY DIESEL GENERATOR**

### **Section 1.0 – Scope:**

Jefferson Parish Department of General Services desires to rent one portable generator for approximately six months on an annual basis. Provide a three (3) year contract to cover all labor, materials, and equipment necessary for the following:

- Furnish one (1) 1250 KW diesel generator
- Deliver and install at the General Government Complex located at 200 Derbigny Street Gretna, LA 70053.
- Provide all required maintenance

### **Section 2.0 –License Requirements:**

The following licenses will be required for this bid:

- Louisiana State Commercial Contractor Licenses in Electrical License and a Specialty License in Installation of Equipment, Machinery and Equipment.

### **Section 3.0 – Bid Specifications:**

The successful bidder shall supply all labor, materials, transportation, shipping, and all other necessary essentials for the following:

- Provide a three (3) year contract for the rental of one (1) 1250 KW portable diesel generator.
- Rental period shall begin on June 1<sup>st</sup> till November 30<sup>th</sup> of each year of this contract.
- Provide one 1250 gallon fuel tank.
- Provide the delivery and setup of the emergency generator at 200 Derbigny Street Gretna, LA 70053 (See attachment “A” for exact location)
- Generator shall be delivered with 100 gallons of fuel to perform start up test on site.
- Jefferson Parish will be responsible for fueling the generator for use throughout the rental period. Jefferson Parish will have the same amount or more of fuel as the same when delivered.
- Provide monthly inspection, maintenance, and testing of generator and fuel tank.
- Provide all parts and labor for repairs of generator and fuel tank at no extra cost to Jefferson Parish.
- No additional fees shall be charged to Jefferson Parish for run hours added to generator.
- In the event of equipment failure during the rental period, the successful bidder shall repair the unit to allow for full operation with no additional charges to Jefferson Parish or replace the unit within 24 hours with no additional charges to Jefferson Parish.
- Remove the generator from the designated Jefferson Parish location and return to the successful bidder’s location.

**Section 4.0 – Existing Structure**

Should any cutting, patching, alteration, or repairs to existing structures, walls, or parts of buildings be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

**Section 5.0 – Liquidated Damages:**

Commencing on the second day following the issuing of the notice to proceed liquidated damages in the amount of \$200/day will be assessed until the generator is delivered and in working condition.

**Section 6.0 – Pre-Construction Conference and Notice to Proceed:**

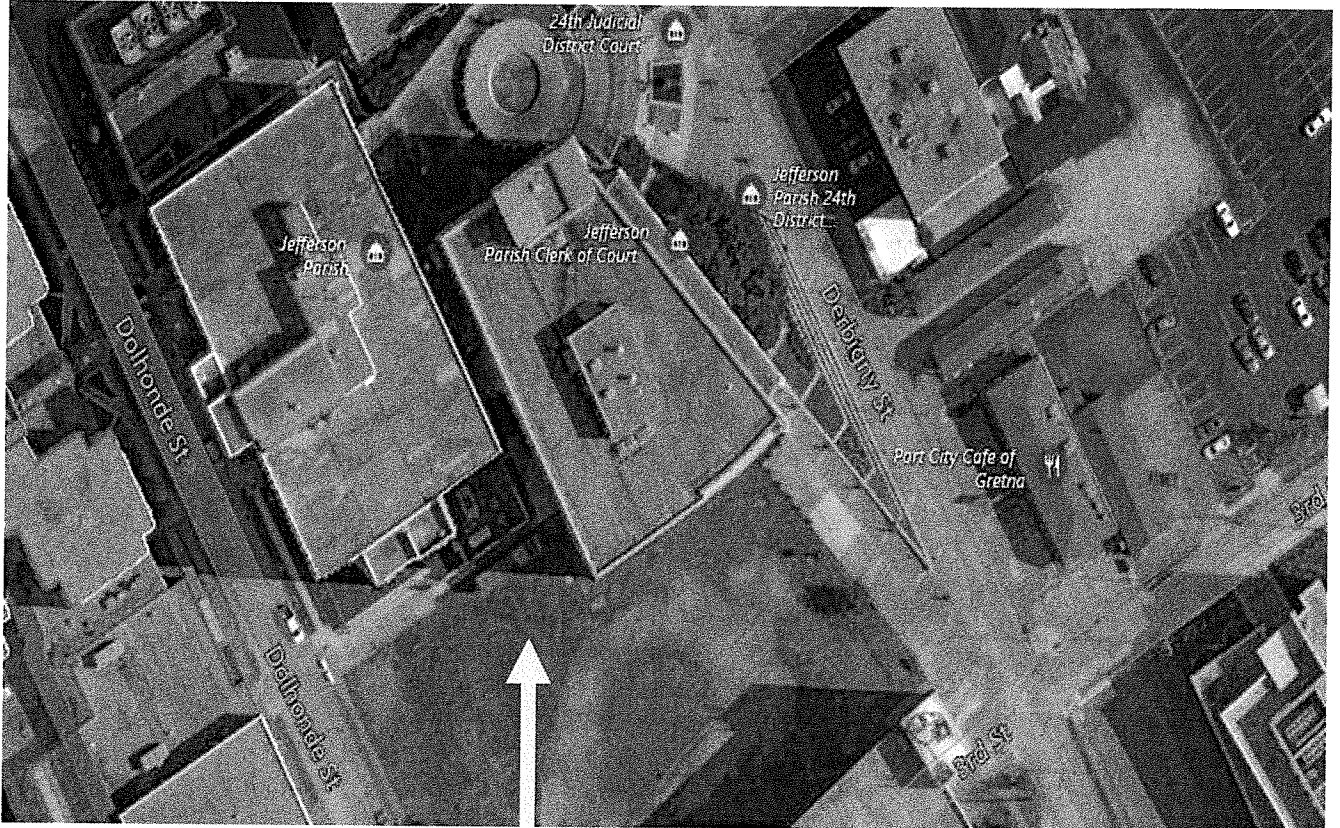
A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences.

Contributions made or costs reasonably anticipated for bona fide fringe benefits under section 1(b)(2) of the Davis-Bacon Act on behalf of laborers or mechanics are considered wages paid to such laborers or mechanics, subject to the provisions of paragraph (a)(1)(iv) of this section; also, regular contributions made or costs incurred for more than a weekly period (but not less often than quarterly) under plans, funds, or programs which cover the particular weekly period, are deemed to be constructively made or incurred during such weekly period. Such laborers and mechanics shall be paid the appropriate wage rate and fringe benefits on the wage determination for the classification of work actually performed, without regard to skill, except as provided in §5.5(a)(4). Laborers or mechanics performing work in more than one classification may be compensated at the rate specified for each classification for the time actually worked therein: *Provided*, That the employer's payroll records accurately set forth the time spent in each

The wage determination (including any additional classification and wage rates conformed under paragraph (a)(1)(ii) of this section) and the Davis-Bacon poster (WH-1321) shall be posted at all times by the contractor and its subcontractors at the site of the work in a prominent and accessible place where it can be easily seen by the workers.

(ii) (A) The contracting officer shall require that any class of laborers or mechanics, including helpers, which is not listed in the wage determination and which is to be employed under the contract shall be classified in conformance with the wage determination. The contracting officer shall approve an additional classification and wage rate and fringe benefits therefore only when the following criteria have been met:

- (1) The work to be performed by the classification requested is not performed by a classification in the wage determination; and
- (2) The classification is utilized in the area by the construction industry; and
- (3) The proposed wage rate, including any bona fide fringe benefits, bears a reasonable relationship to the wage rates contained in the wage determination.

(B) If the contractor and the laborers and mechanics to be employed in the classification (if known), or their representatives, and the contracting officer agree on the classification and wage rate (including the amount designated for fringe benefits where appropriate), a report of the action taken shall be sent by the contracting officer to the Administrator of the Wage and Hour Division, Employment Standards Administration, U.S. Department of Labor, Washington, DC 20210. The Administrator, or an authorized representative, will approve, modify, or disapprove every additional classification action within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30-day period that additional time is necessary.

(C) In the event the contractor, the laborers or mechanics to be employed in the classification or their representatives, and the contracting officer do not agree on the proposed classification and wage rate (including the amount designated for fringe benefits, where appropriate), the contracting officer shall refer the questions, including the views of all interested parties and the recommendation of the contracting officer, to the Administrator for determination. The Administrator, or an authorized representative, will issue a determination within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30-day period that additional time is necessary.

(D) The wage rate (including fringe benefits where appropriate) determined pursuant to paragraphs (a)(1)(ii) (B) or (C) of this section, shall be paid to all workers performing work in the classification under this contract from the first day on which work is performed in the classification.

(iii) Whenever the minimum wage rate prescribed in the contract for a class of laborers or mechanics includes a fringe benefit which is not expressed as an hourly rate, the

The Secretary of Labor may require the contractor to set aside in a separate account assets for the meeting of obligations under the plan or program.

*(2) Withholding.*
