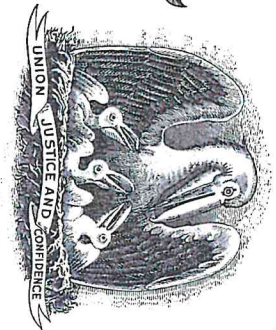

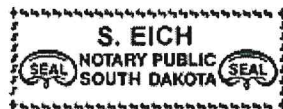

REVISIONS TO SPECIFICATIONS:

Replace Sections 9.0 thru 10.1 of original specifications with the below information.

Section 9.0 - Specifications

- All materials for this project shall be bidder supplied new.
- All materials shall be as specified or owner reviewed and approved equal.
- The successful bidder shall take all necessary precautions to protect the roof of the building. Any damage to the roof due to this work shall be repaired at no additional cost to the owner by a roofing company authorized to perform repair work on this type of roof system. All roof work shall be performed by authorized roofing material contractor. All roof work shall not void any existing roof warranties.
- Before any work is to begin an owner's representative and the successful bidder shall inspect, document, and take photos of all existing building and roof conditions.

Section 9.1 - Condensing Units:

- Supply and install the following air cooled condensing units on the roof of the facility:
 - One (1) new American Standard Model # TTA090G300A 14 seer 7.5 ton 208/230 volt 3 phase DX air cooled condensing unit with one (1) new American Standard Model # BAYLOAM103 low ambient control head pressure kit.
 - Four (4) new American Standard Model # 4A6C4036A3000A 14 seer 3 ton 208/230 volt 3 phase DX air cooled condensing units with one (1) new American Standard Model # BAYLOAM103 low ambient control head pressure kit for each unit.
 - Five (5) new American Standard Model # 4A7C4060A3000A 14 seer 5 ton 208/230 volt 3 phase condensing units with one (1) new American Standard Model # BAYLOAM103 low ambient control head pressure kit for each unit.
- Remove and properly dispose of ten (10) existing DX air cooled condensing units.
- Recover all refrigerant and place in owner provided cylinders.
- Remove full refrigerant cylinders from roof and place on ground. Owner will take possession of cylinders once on ground.
- Flush all refrigerant lines as per manufactures recommendations and guidelines.
- Re-Secure each new condensing unit to existing platform using existing strapping materials.
- Re-connect high and low side copper tubing to each new bidder supplied condensing unit.
- Successful bidder shall supply all copper fittings and tubing needed to properly re-connect high and low side copper tubing to each unit.
- Soft drawn tubing will not be allowed on this project.
- All joints shall be soldered.

Section 9.1 - Condensing Units: (Continued)

- Supply and install new properly sized pipe insulation on low side copper tubing on each bidder supplied unit.
- Insulation shall be replaced from pitch pocket to new unit.
- All insulation shall have a ¾ inch minimum wall thickness.
- Paint all pipe insulation with Armaflex AR040494 WB Finish UV Resistant white Coating.
- Remove and properly dispose of two (2) existing General Electric circuit breaker panels and all circuit breakers.
- Supply and install two (2) new NEMA 3 rated Square D circuit breaker panels. See Attachment "A" for location
- Supply and install one (1) new properly sized Square D circuit breaker for each new bidder supplied condensing unit. (For a total of ten (10) breakers)
- Supply and install one (1) new hot dipped galvanized support stand for each new bidder supplied circuit breaker panel. (For a total of two stands)
- All electrical equipment shall be weather tight and UL approved.
- Supply and install new Liquid tight flexible electrical conduit (sealtite) and properly sized copper wire from new circuit breaker disconnect to each new condensing unit.
- Re-Install existing low voltage electrical wire for each new condensing unit in bidder supplied electrical conduit.
- No exposed control wiring will be accepted all wire shall be placed in conduit.
- All conduit shall be properly mounted to unit support platform.
- All mounting hardware shall be stainless steel.

- Remove and properly dispose of ten (10) existing DX air handler units and all associated items. (See section 8.0 for list of units)
- Supply and install the following air handler units: (See section 8.0 for Locations)
 - One (1) new American Standard Model # TWE090D300A 7.5 ton 208/230 volt 3 Phase air handler unit with a BAYHTRL325A heat strip kit. (See section 8.0 for Location of air handler)
 - Five (5) new American Standard Model # TEM4A0C60S51SA 5 ton 208/230 volt 1 phase air handler units with a BAYHTR1515BRKA heat strip kit in each air handler. (See section 8.0 for Location of air handlers)
 - Four (4) new American Standard Model # TEM4A0B36S31SB 3 ton 208/230 volt 1 phase air handler units with a BAYHTR1508BRKA heat strip kit in each air handler.(See section 8.0 for Location of air handlers)
- Supply and install new ridged conduit and properly sized copper wire from each existing disconnect to each new air handler unit (For a total of ten (10) ridged conduits and wires)

- Conduit shall match existing conduit.
- Design/engineer, supply, and install one (1) new 26 gauge sheet metal plenum on each new bidder supplied air handler unit. (For a total of ten (10) plenums)
- Re-install all existing duct work to each new air handler unit as needed.
- If additional duct work is needed to properly install new units it will be the successful bidder's responsibility to design/engineer, supply, and install new duct work to match existing ductwork.

- Pan float switch shall be wired to air handler and shall shut unit off in the event of switch activation.
- Supply, and install new schedule 40 PVC primary drain line with "P" trap from new air handler unit to existing drain line.
- Supply and install one (1) new Honeywell commercial touch screen thermostat Model: TB822U1003 or owner reviewed and approved equal to each new air handler unit (For a total of ten (10) new thermostats). (Location provided by owner at pre-construction conference)
- Supply and install new 24 volt, 18 gauge, and 6 wire thermostat wire from air handler unit to each new thermostat.
- Re-connect existing duct detectors to fire alarm system
