CHANGES TO JEFFERSON PARISH BIDDING PROCEDURES

Bidders may submit bid responses at this location, pending authorization in each bid package. **Bidders should carefully read and must respond accordingly per the requirements of the bid packages. NOTE: Bidders submitting bids on the day of bid opening, bidders must submit at the West Bank location only.**

Other Changes Continued:

- For all advertised bids, corporate resolutions and/or written evidence of signature authority must be included with bid submission.
- Effective June 1, 2017, bidders may no longer send bid responses via facsimile, as some bid solicitations may provide. Vendors responding to bid solicitations may only submit via USPS, courier service, hand delivery or via online by registering free of charge at www.jeffparishbids.net. TWO (2) YEAR CONTRACT FOR MECHANICAL STREET CLEANING FOR THE JEFFERSON PARISH DEPARTMENT OF PARKWAYS

SECTION 1.0 – SCOPE:

Labor, materials, and equipment necessary to furnish Mechanical Street Sweeping for the 2018 and 2019 parade season, which is estimated to be approximately 850 hours of work, and for other Mechanical Street Sweeping, estimated to be approximately 300 hours of work per year, in Jefferson Parish for 2018 and 2019 for the Department of Public Works, Parkways Department. The additional 300 hours of street sweeping is not guaranteed and is at the sole discretion of the Department of Public Works, Parkways Department.

The term of this contract shall be for two (2) years. The contract shall commence 12/09/2017.

SECTION 2.0 – BONDS:

A surety bond in the amount of 5% of the total bid price is required with the bid response.

The successful bidder will be required to furnish a performance bond as security for the performance of this contract and said bond must be in the amount of 50% of the value of the contract. The performance bond is due upon signing the contract.

SECTION 3.0 – BID SPECIFICATIONS:

The successful bidder shall provide labor, materials and equipment necessary to furnish approximately 850 hours of Three-Broom Mechanical Street Sweeping per parade season. Successful bidder has the possibility of an additional 100 hours, at the sole discretion of the Department of Public Works, Parkways Department, to sweep the West Bank and East Bank routes while in town for the parades. In addition to the parade season work, the successful bidder will have the possibility of performing up to an additional 300 hours for other Three-Broom Mechanical Street Sweeping per year (non-parade) in Jefferson Parish for 2018 and 2019 for the Department of Public Works, Parkways Department.

The successful bidder will provide support for clean-up by providing three-broom mechanical street sweepers for clean-up during and after every parade, in accordance with the published Mardi Gras, St. Patrick's and Irish Italian Parades scheduled by Jefferson Parish.

The Parish will provide dump trucks on the parade routes for the street cleaning machines.

The successful bidder will be reimbursed for clean-up from reporting time to ending time. Reporting time shall not be more than 1 hour before start of parade. If there is more than one parade, reporting time shall be one hour before the last parade starts.

If the parade is cancelled for any reason, then the successful bidder will not be paid when parades are combined as a result of a previous rain delay. There will be no extra expense incurred by Jefferson Parish. Jefferson Parish has a set plan in place for the parade clean-up. Successful bidder must work within these parameters.

In addition to two-way radios in all vehicles, the successful bidder shall provide one hand held two-way radio with battery charger in all vehicles and one for the director of Parkways, to use -- to communicate with the successful bidder's personnel and office location.

The work under this contract shall consist of the items contained in the general specifications, including all incidentals, equipment, personnel, and materials necessary to fully complete said work in accordance with the contract documents. Successful bidder must have available at least thirteen (13) three-broom mechanical street sweepers per parade season, to be designated specifically for this contract. Copies of registration certificates or lease agreements for the Three-Broom Mechanical Street Sweepers must be provided with the bid, or the bid response will be deemed non-responsive. **NON-PARADE SEASON LINE ITEMS TO BE PROVIDED ON AN AS NEEDED BASIS.**

A list of equipment that the successful bidder intends on using for performance of this contract must be provided with the bid and meet the minimum equipment requirement standards (SEE ATTACHMENT "A").

SECTION 4.0 – METHOD OF OPERATIONS:

All operations described in these specifications shall be conducted by the successful bidder's personnel and/or prior approved subcontractors. The successful bidder shall be responsible for the expense of all such operations.

The successful bidder shall provide own equipment, labor, fuel, and any other materials necessary to complete the required work. The successful bidder shall be responsible for the maintenance and repair of own equipment; and, the availability, presence, and supervision of successful bidder's employees. Additionally successful bidder shall provide adequate support equipment, including pick-up trucks and any other item of equipment necessary to provide cleaning services as described in these specifications.

The successful bidder is required to have a competent and experienced supervisor/foreman on duty during each shift when work is being performed under this contract; mechanic with fully equipped service vehicle. **The use of subcontractors for this contract must be approved in written consent by the Parkways Director and the Parish Council.**

SECTION 5.0 – EQUIPMENT:

Three-broom mechanical street sweepers with rubber conveyor or elevator system – **no chains.**

All three-broom mechanical street sweepers must have minimum capacity of four cubic yards or more and be equipped with adequate water systems for dust control. All sweepers must be equipped with dual steering and dual side and gutter brooms.

All equipment (including support equipment) to be used by the successful bidder is subject to the inspection and final approval of the Parish. Such approval may require onsite demonstration of the capability of any proposed equipment. The Parish shall have the option to perform a complete inspection of all vehicles at any time throughout the term of the contract. Should any vehicle when inspected, and in the determination of the Parish, not meet standards necessary to complete the contract or to operate safely, the Parish may require such a vehicle to be brought to standard before being placed back in service.

All equipment (including support equipment) shall be equipped with two-way radio communication designed for commercial use. CB Radios are unacceptable. See **Minimum Equipment List “Attachment A”.**

SECTION 6.0 – LIQUIDATED DAMAGES:

Failure to file an itemized time work sheet report per machine day/night within five (5) working days, shall result in liquidated damages of twenty-five dollars (\$25.00) per day until such time as the report is filed. Separate reports for the Eastbank and Westbank are required.

Failure of a sweeper to show up for a parade or non-parade will result in liquidated damages of one thousand dollars (\$1,000.00) per sweeper. The liquidated damages described herein may be waived, at the sole discretion of the Parish for circumstances beyond the control of the successful bidder. In the event said liquidated damages are assessed, it is understood and agreed that the above sums shall be deducted as liquidated damages, and not as a penalty. Such liquidated damages shall be deducted from the amount due to the contractor for the period in which the deficiency occurs.

SECTION 7.0 – CERTIFICATIONS:

Successful bidder must obtain all permits, licenses and registrations required by federal, state, and local authorities relative to mechanical street sweeping services.

Successful bidder must comply with all applicable federal, state, and local laws, rules, regulations, and permits relative to the mechanical street sweeping services; and, the mechanical street sweepers shall be equipped as required by applicable federal, state, and local laws, ordinances, rules, and regulations.

The successful bidder shall be responsible for the safety of the public and the convenience of traffic while performing the referenced services, unless otherwise directed.

Successful bidder must provide qualified operators for each sweeper utilized. Successful bidder must provide necessary mechanical support including tire repair capacity, fuel, and parts support for each machine.

SECTION 8.0 – PAYMENT:

Payment of mechanical street sweeping shall be made by the contract unit price per hour actually cleaned. For the purposes of this contract "actually cleaned" means the removal of all dirt, dust, debris, grass, and foreign objects from a particular location.

THE FOLLOWING INSTRUCTIONS APPLY TO ALL BIDS

All bids submitted are subject to these instructions and general conditions and any special conditions and specifications contained herein, all of which are made part of this bid proposal reference. By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 113646 and/or Resolution No. 113647.

All vendors submitting bids should register as a Jefferson Parish vendor if not already yet registered. Registration forms may be downloaded from <http://purchasing.jeffparish.net> and by clicking on Vendor Information. Current W-9 forms with respective Tax Identification numbers and vendor applications may be submitted at any time; however, if your company is not registered and/or a current W-9 form is not on file, vendor registration is mandatory. Further, a current W-9 form and respective Tax Identification number must be supplied upon contract execution, should you be awarded a contract and/or issued purchase order. Failure to do so may result in delay of payment.

All quotations shall be based on F.O.B. Agency warehouse or job site, anywhere within the Parish as designated by the Purchasing Department. This provision does not apply to public works projects

JEFFERSON PARISH requires all products to be new (current) and all work must be performed according to standard practices for the project. Unless otherwise specified, no aftermarket parts will be accepted. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated and/or supporting documentation supplied with bid submission.

Bidders should submit all questions in writing and fax them to the Purchasing Department at (504) 364-2693 no later than FIVE (5) working days prior to bid opening. Bid numbers should be mentioned in all requests. Questions may also be emailed to the buyer for this bid at the email address listed above. If submitting online, vendors may send questions via the E-Procurement site no later than Five (5) working days prior to the bid opening.

If this bid requires a pre-bid conference (see Additional Requirements section), bidders are advised that such conference will be held to allow bidders the opportunity to identify any discrepancies in the bid specifications and seek further clarification regarding instructions. The Purchasing Department will issue a written response to bidders' questions in the form of an Addendum. Please note that all official communication will be expressed in the form of an addendum.

All formal Addenda require written acknowledgement on the bid form by the bidder. Failure to acknowledge an Addendum on the bid form shall cause the bid to be rejected. JEFFERSON PARISH reserves the right to award bid to next lowest responsive and responsible bidder in this event.

The purpose and intention of this invitation to bid is to afford all suppliers an equal opportunity to bid on all construction, maintenance, repair, operating supplies and/or equipment listed in this bid proposal. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications.

JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. Bidders are required to complete, sign and return the bid form and/or complete and return the associated line item pricing forms as indicated. Vendors must not alter the bid forms. Doing so will cause the bid to be rejected.

A corporate resolution or written evidence of the individual signing the bid having such authority must be submitted with the bid. Failure to comply will cause bid to be rejected. For corporate entities, such written evidence may be a printout of the Louisiana Secretary of State's website listing the signatory as an officer. Such printout shall be included with the bid submission. Bids submitted by Owners or Sole Proprietorships must include certification that he or she owns the entity for which the bid is signed. This documentation must be submitted with the bid. Failure to do so will result in bid rejection.

INSTRUCTIONS FOR BIDDERS AND GENERAL CONDITIONS

A. AWARD OF CONTRACT: JEFFERSON PARISH reserves the right to award contracts or place orders on a lump sum or individual item basis, or such combination, as shall in its judgment be in the best interest of JEFFERSON PARISH. Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.

All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar days.

PROTESTS: Only those vendors that submitted a bid in response to this solicitation may submit a protest in writing to the Director of the Purchasing within 48 hours of bid opening. The Purchasing Director will review it in connection with the Parish Attorney's Office which will then respond in writing as soon as possible.

PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. "LSA - R.S. 38:2251-2261"

B. USE OF BRAND NAMES AND STOCK NUMBERS: Where brand names and stock numbers are specified, it is for the purpose of establishing certain minimum standards of quality. Bids may be submitted for products of equal quality, provided brand names and stock numbers are specified. Complete product data may be required prior to award.

C. CANCELLATION OF CONTRACT: JEFFERSON PARISH reserves the right to cancel all or any part if not shipped promptly. No charges will be allowed for parking or cartage unless specified in quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH reserves the right to cancel any contract at anytime and for any reason by issuing a THIRTY (30) day written notice to the contractor.

For good cause and as consideration for executing a contract with Jefferson Parish, vendor conveys, sells, assigns and transfers to Jefferson Parish or its assigns all rights, title and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of Louisiana, relating to the particular good or services purchased or acquired by Jefferson Parish.

D. PRICES: Jefferson Parish is exempt from paying sales tax under LSA-R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and unless otherwise specified, shall be exclusive of state and Parish taxes. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail.

Quantities listed are for bidding purposes only. Actual requirements may be more or less than quantities listed.

Bidders are not to exclude from participation in, deny the benefits of, or subject to discrimination under any program or activity, any person in the United States on the grounds of race, color, national origin, or sex; nor discriminate on the basis of age under the Age Discrimination Act of 1975, or with respect to an otherwise qualified handicapped individual as provided in Section 504 of the Rehabilitation Act of 1973, or on the basis of religion, except that any exemption from such prohibition against discrimination on the basis of religion as provided in the Civil Rights Act of 1964, or Title VI and VII of the Act of April 11, 1968, shall also apply. 1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner.
3. Contractor must hold current applicable JEFFERSON PARISH licenses with the Department of Inspection and Code Enforcement. Contractor shall obtain any and all permits required by the JEFFERSON PARISH Department of Inspection and Code Enforcement. The contractor shall be responsible for the payment of these permits. All permits must be obtained prior to the start of the project. Contractor must also hold any and all applicable Federal and State licenses. Contractor shall be responsible for the payment of these permits and shall obtain them prior to the start of the project.
4. A LA State Contractor's License will be required in accordance with LSA R.S. 37-2150 et. seq. and such license number will be shown on the outside of the bid envelope. Failure to comply will cause the bid to be rejected. Additionally if submitting the bid electronically, then the license number must be entered in the appropriate field in the Electronic Procurement system. Failure to comply will cause the bid to be rejected.
5. It is the bidder's responsibility to visit the job site and evaluate the job before submitting a bid.
6. Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Flammable material must be removed from the job site daily because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare of JEFFERSON PARISH and the general public.

7. **PUBLIC WORKS BIDS:** All awards for public works in excess of \$5,000.00 will be reduced to a formal contract which shall be recorded at the contractor's expense with the Clerk of Court and Ex-Officio Recorder of Mortgages for the Parish of Jefferson. A price list of recordation costs may be obtained from the Clerk of Court and Ex-Officio Recorder of Mortgages for the Parish of Jefferson. All awards in excess of \$25,000.00 will require both a performance and a payment bond. Unless otherwise stated in the bid specifications, the performance bond requirements shall be 100% of the contract price. Unless otherwise state in the bid specifications, the payment bond requirements shall be 100% of the contract price. Both bonds shall be supplied at the signing of the contract.
8. **NON-PUBLIC WORKS BIDS:** A performance bond will be required for this bid. The amount of the bond will be 100% of the contract price unless otherwise indicated in the specifications. The performance bond shall be supplied at the signing of the contract.
9. **NON-PUBLIC WORKS BIDS:** A payment bond will be required for this bid. The amount of the bond will be 100% of the contract price unless otherwise indicated in the specifications. The payment bond shall be supplied at the signing of the contract.
10. Unless otherwise stated in the bid specifications, the successful bidder will be required to procure standard insurance policies evidencing Parish-mandated insurance requirements as indicated on the attached "insurance requirements" sheet. All bidders must comply with the instructions in this sheet. Failure to comply will cause bid to be rejected.
11. A bid bond will be required with bid submission in the amount of 5% of the total bid, unless otherwise stated in the bid specifications. Acceptable forms shall be limited to cashier's check, certified check, or surety bid bond.
