3. The Contractor is responsible to establish the trees and turf as part of this contract.
4. Method(s) of irrigating the trees and turf to establishment shall be as the Contractor determines.
5. All existing limestone and lime powder shall be removed completely from all the existing electrical conduit trenches (depth as required). The Contractor shall ensure no limestone or lime powder is left at any site.
6. The Contractor shall ensure that the '419' Bermuda sod does not include any rye seed. The submittal from the sod grower shall state that no rye seed is included in the sod proposed for this project.

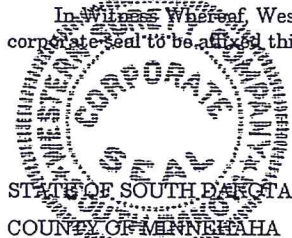

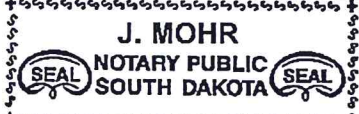

General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Purpose of Form

A person who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) to report, for example, income paid to you, real estate transactions, mortgage interest you paid, acquisition or abandonment of secured property, cancellation of debt, or contributions you made to an IRA.

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN to the person requesting it (the requester) and, when applicable, to:

- Certify that the TIN you are giving is correct (or you are waiting for a number to be issued),
- Certify that you are not subject to backup withholding, or
- Claim exemption from backup withholding if you are a U.S. exempt payee. If applicable, you are also certifying that as a U.S. person, your allocable share of any partnership income from a U.S. trade or business is not subject to the withholding tax on foreign partners' share of effectively connected income.
