**SCOPE OF WORK:**

The Jefferson Parish Department of Public Works – Parkways Department (Parkways) is soliciting bids from qualified suppliers of LED holiday light displays designed to be mounted to wood utility poles. Bidders' pricing shall be inclusive of all products, freight and incidentals required to supply the selected decorations. Bidders shall refer to Resolution No. 113646, as amended, which provides a uniform set of "General Conditions and Agreement for all contractors engaged in performing work or services for the Parish of Jefferson".

**DECORATION SPECIFICATIONS**

This bid shall be for the purchase of pole mounted holiday decorations. Each decoration shall be constructed of a powder coated steel, aluminum, stainless steel or galvanized steel frame. Each decoration shall include all required hardware, including lag screws, for mounting the unit to an existing wood utility pole. Mounting hardware shall be constructed from powder coated steel, aluminum, stainless steel or galvanized steel.

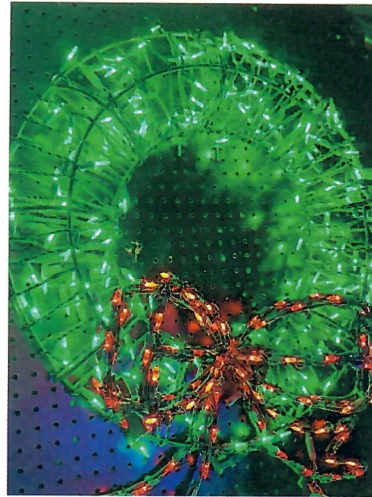
The decorations shall include LED lighting operable by a standard 120V male plug connector. All wiring shall be 18 gauge (minimum) commercial grade. All LED lighting can be white, various colors or a combination of colors. All white LED lighting shall have a color temperature range from 3,000K to 4,000K. All supplied decorations must include similar color schemes between the fixtures.

Each decoration shall have an average minimum dimension (height and width) of 6'-0". The decorations shall be of various 'holiday' designs (see below imagery). The maximum weight of each fully assembled decoration shall not exceed 50 lbs.

This contract shall include a total of twenty-three (23) pole mounted decorations consisting of various 'holiday' themed designs. Themed designs shall include, but not be limited to, snowflakes, candy canes, wreaths, holiday trees, snowmen and ornaments. Themed designs shall not include any religious symbols. All proposed designs shall be approved by the Parkways Department prior to shipping and delivery.

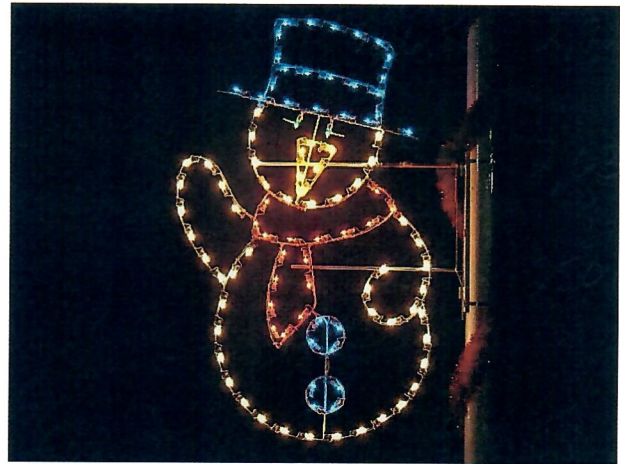

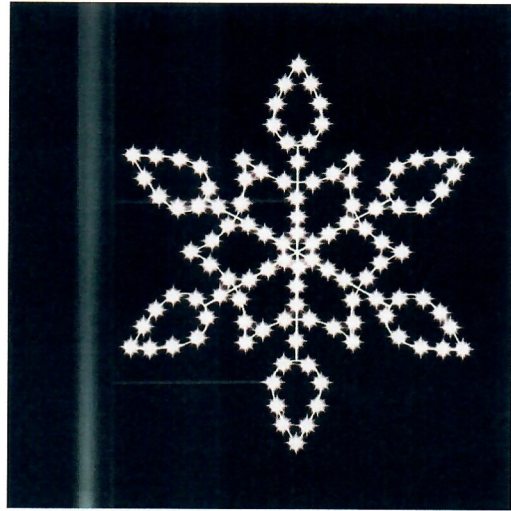

**WARRANTY**

All decorations shall include a minimum one (1) year manufacturer's or supplier's warranty.

**DELIVERY**

All decorations shall be available for pickup within Jefferson Parish, or shall be delivered in a single shipment to the Jefferson Parish Parkways Department at 1901 Ames Boulevard, Marrero, LA 70072. A minimum of twenty-four (24) hours of notification shall be provided to the Parkways Department in advance of the delivery. All decorations shall be delivered in clearly labeled, unopened, packaging. As needed, off-loading of crates and/or pallets will be performed at the delivery location by the Parkways Department personnel.

All items will be inspected by Parkways Department personnel at the time of off-loading. Any damaged items shall be photographed, documented and returned to the manufacturer or supplier at no cost to the Parkways Department.
