All awards in excess of \$25,000.00 will require both a performance and a payment bond. 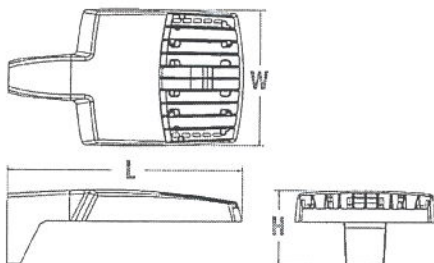

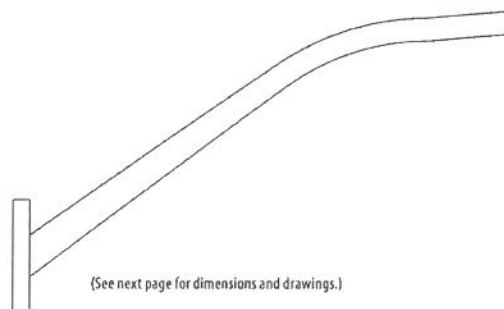
