Section 1.0 – NON-MANDATORY SITE VISIT:

Site can be visited 8-4 Monday – Friday. Please call Brandon Collins at 504-349-5006 to set up a visit. Failure to visit shall not relieve the bidder of responsibility for information discussed at the site. Furthermore, failure to inspect job site does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner. This visit is held to allow questions to be answered and to inspect the site with the owner's representative.

Section 2.0 – Scope:

We extend this bid to cover all labor, materials and necessary essentials to replace one (1) air conditioning unit at Terrytown Playground

Section 3.0 – License Requirements

The following Louisiana State license shall be required for this job:

- **Mechanical work** (Major Classification and all sub-classifications under it)

Section 4.0 – Quantities/Inspection:

Bidders must inspect the site in order to determine the proper quantity of materials and equipment required to complete this project.

Section 5.0 – Bid Specifications:

The successful bidder shall supply all labor, materials, and necessary essentials to perform the following at Terrytown Playground, 641 Heritage Ave, Terrytown 70056:

- Contractor shall remove and dispose of existing outdoor condensing unit
- Furnish and install (1) one new Trane 25 Ton Package Air Cooled Condensing Unit, Model number RAUJC254B, or equal, with the following options:
 - Low ambient louvers
 - Phase monitor
 - Coil guards
 - Suction and liquid line ball valves
 - Rubber isolation
 - Compressor circuit breaker
 - 460V, 3 Phase
 - Coated condenser coil
- Replace outdoor disconnect box, fuses and electrical wire feeding condensing unit.
- Contractor shall remove existing hot gas reheat coil, reclaim value and associated piping. Install quadrant handle on face and bypass dampers to leave in fully open position. Patch and seal all holes in panel

- Replace (4) TXV valves with R401A type. Replace liquid line solenoid valves and orient with compressor staging
- Flush all refrigerant line and pressurize for 48 hours at 400 PSI to insure no leak in refrigerant lines.
- Replace liquid line core drier, evacuate to 400 microns
- Furnish and install (1) 10HP VFD with bypass
- Chemically clean and sanitize existing DX coil, blower housing, wheel and interior cabinet section. Provide Merve 8 filters
- Remove and dispose of existing Trane, or equal, Control System
- Provide and install DDC controller with remote interface panel to be located in supervisor's office. Control system shall contain schedule for occupied and unoccupied times. Controller shall contain the following:
 - Supply air temperature
 - CO2
 - Mixed air sensor
 - RA temperature
 - Space sensor
 - Outdoor air sensor
 - Fan proof switch
 - SCR heater
 - 2 stages of cooling
 - Motorized outdoor air damper
 - Wall mounted user temperature adjustment with override
 - 2 speed blower operation for capacity reducing on cooling
- Contractor shall perform balancing of total air flow based on original mechanical design (provided by JPRD) including outdoor CFM.
- Perform system startup and programming
- Contractor is responsible for providing crane/forklift for removal of equipment.
- All work must be done in a workmanship like manner

Section 6 – Bond Requirements:

Section 7 – Hours of Work:

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days prior to execution. The successful bidder shall work normal building work

hours (8:00 am – 4:00 pm) to provide a safe work environment at no extra charge to Jefferson Parish.

Section 8 – Cleaning and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish Officials.

Section 9.0 – Existing Structure

Should any cutting, patching, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

Section 10.0 – Warranty:

 - 1-year Parts and Labor

 - 5 years

Section 11.0 – SDS:

The bidder shall notify the Jefferson Parish Department of Recreation contact person of any hazardous substances that will be brought to and/or used at the workplace. The bidder shall provide SDS as per this requirement to the Director of Jefferson Parish Recreation Department.

Section 12.0 -Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement. The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project.

Section 13.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No work shall be performed until the successful bidder receives a written “Notice to Proceed” to begin work from the Department of Recreation.

Section 14.0 – Construction Term:

Upon receiving a notice to proceed, the bidder agrees that work shall be completed as follows:
Vendor agrees to commence actual physical work on the site with an adequate force and equipment within 10 days from the date of Notice to Proceed. All work shall be substantially completed in **NINETY (90)** consecutive calendar days from the Notice to Proceed.

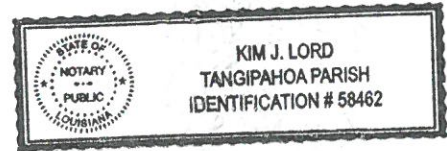
