

Section 1.0 - Site Visits:

Section 2.0 – Scope:

We extend this proposal to provide labor, materials, delivery, equipment, and all other incidentals necessary to clean the exterior walls, mullions, windows, concrete flatwork, exterior stairways, handicapped ramps, and front and rear driveways at the Jefferson Performing Arts Building located at 6400 Airline Drive Metairie, Louisiana 70003.

Section 3.0 –License Requirements:

A Louisiana State Contractor's License will be required by LSA R.S. 37-2150 et. seq., and such license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected.

Section 4.0 – Quantities/Inspection:

Bidders must inspect the site and perform their measurements to determine the proper quantity of labor, materials, and equipment required to complete this project.

Section 5.0 - Submittals:

If the bidder intends to provide materials equal to or better than owner-specified materials, the following shall be provided with the bid submission. Failure to provide the requested information with your bid will result in the bid being deemed non-responsive.

- Manufacturer's catalog data
- Detail sheets
- Specifications of product
- Warranty information

Section 6.0 - Bid Specifications:**The following shall be performed before work begins:**

- Provide labor and materials needed to protect all landscaping, visitors, occupants, vehicles, walkways, windows, roofs, etc., while work is being performed during normal working hours and after normal working hours.

6.1 Cleaning Exterior of the Building:

- Pressure wash all exterior walls, exterior stairs, and all concrete flatwork. See attachment "A"
- Pressure washing shall remove all loose materials, dirt, foreign materials, etc., to provide a properly clean finish.
- All windows shall be spot and streak free.

6.2 Cleaning Exterior Windows:

- Clean all exterior windows and mullions.
- Remove all dirt, calcium, hard water spots, and buildup from glass panels and mullions.
- Remove excess water from mullions after cleaning.

Section 7.0 – Hours of Work:

Work that shall not affect the normal operation of this facility can be scheduled during normal working hours Monday thru Friday, 7:00 a.m. – 4:00 p.m. Any work that may affect persons' safety or property damage must be scheduled after normal working hours or on weekends at no extra cost to Jefferson Parish.

Section 8.0 – Existing Structure:

If the successful bidder should damage or destroy any part of a building, vehicles, parking lots, irrigation system, fencing, landscaping, etc., the successful bidder shall be required to replace and restore said item to its original condition with the same type of material, finish, and workmanship at no additional cost to the owner.

Section 9.0 – Liquidated Damages:

Commencing on the forty-fifth day following the notice to proceed until work is substantially complete, liquidated damages will be assessed in the amount of \$300/day.

Section 10.0 – Start of Work Conference and Notice to Proceed:

A "Start of Work Conference" shall be held between the successful bidder and the owner before any work commences.

No materials shall be ordered until the successful bidder receives a written "Notice to Order Materials" from the Department of General Services.

No work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work from the Department of General Services.
