On behalf of SLSCO LTD. (SLS), I am pleased to present this bid to provide and maintain portable toilets and hand washing stations on an as needed basis for the Jefferson Parish Department of Emergency Management.

SLS Commitment to Jefferson Parish

SLS has a proven record of serving Jefferson Parish. During Hurricane Ida, our team mobilized within 12 hours, deploying restroom, shower, laundry trailers, handwashing stations, generators, and potable water across Jefferson Parish, including the City of Kenner and Grand Isle. We supported a 100-person base camp in Grand Isle. We also provided over 34,000 meals, 25 pallets of ice, and other critical resources to local agencies such as the Jefferson Parish Sheriff's Office and Department of General Services.

Understanding of Scope

SLS is prepared to deliver the following to Jefferson Parish on demand:

- **Portable Toilets:** SLS will supply standard and ADA-compliant fiberglass toilet units, constructed to specified dimensions and equipped with ventilation grills, interior door handles, and closure mechanisms. Units are available for daily, weekly, or monthly rental and include delivery and pickup within 24 hours during emergency activations.
- **Handwashing Stations:** SLS will provide 2-stall handwashing stations with 20-gallon fresh water tanks and 22-gallon gray water tanks. Each unit accommodates 300+ uses and will be stocked with hand soap and paper towels during service.
- **Servicing and Compliance:** All units will be regularly cleaned, restocked, and maintained in compliance with Louisiana Department of Environmental Quality standards. Waste will be disposed of at permitted sites, and damaged units will be repaired or replaced within 24 hours of request.

We appreciate the opportunity to continue serving the people of Jefferson Parish. Thank you for your consideration. We look forward to hearing from you.

In late August 2021, the impact of Hurricane Ida caused extensive damage throughout the state of Louisiana and left more than one million residents without power. SLS provided fueling services, catering, sheltering support, showers, toilets, and other equipment for five agencies, mobilizing within twelve hours of activation.

SLS was engaged to provide: Emergency generators to fourteen individual sites statewide, 150 pallets of water, ten pallets of ice, 50,000 meals, 160,000 gallons of fuel, temporary restrooms, showers, and laundry trailers to locations statewide, and potable water tanks.

SLS provided the following additional services to the State of Louisiana: Emergency shelter for 100 persons in St. Charles Parish, 100-person support camp in Grand Isle, which provided HVAC, generators, catering, tables, and chairs, and restroom and shower trailers for Terrebonne Parish residents evacuated to Monroe, LA.

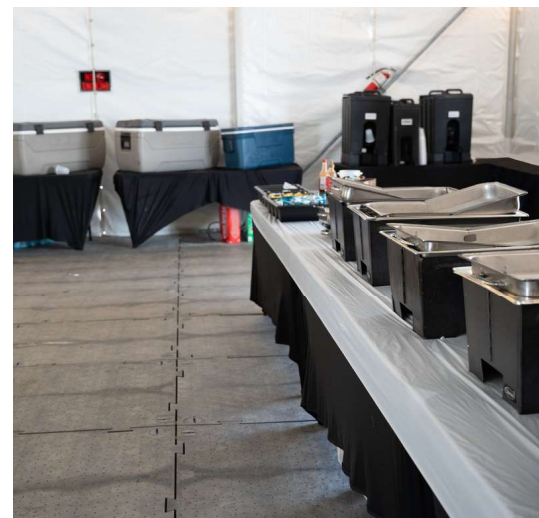

In response to Hurricane Beryl's landfall in July 2024, SLS was activated by the TxDOT to establish two base camps for housing and feeding first responders and TxDOT personnel. On July 8, 2024, SLS quickly mobilized within four hours to set up a base camp at the Sugar Land TxDOT facility. The camp accommodated 100 occupants and providing mobile lodging trailers, restroom trailers, shower trailers, and laundry trailers, along with food services. The camp saw a peak of 194 responders by July 16, with 5,800+ meals served during 12 days of operations. The camp was fully operational within 12 hours, offering continuous support to personnel working to restore infrastructure after the hurricane.

SLS was activated again on July 10, 2024, to set up a base camp at TxDOT Houston headquarters. Within 27 hours, the camp was operational, providing lodging for 36 responders and meals for up to 135 personnel with a total of 1,840 meals served over seven days.

Contributions made or costs reasonably anticipated for bona fide fringe benefits under section 1(b)(2) of the Davis-Bacon Act on behalf of laborers or mechanics are considered wages paid to such laborers or mechanics, subject to the provisions of paragraph (a)(1)(iv) of this section; also, regular contributions made or costs incurred for more than a weekly period (but not less often than quarterly) under plans, funds, or programs which cover the particular weekly period, are deemed to be constructively made or incurred during such weekly period. Such laborers and mechanics shall be paid the appropriate wage rate and fringe benefits on the wage determination for the classification of work actually performed, without regard to skill, except as provided in § 5.5(a)(4). Laborers or mechanics performing work in more than one classification may be compensated at the rate specified for each classification for the time actually worked therein: Provided, That the employer's payroll records accurately set forth the time spent in each classification in which work is performed. 

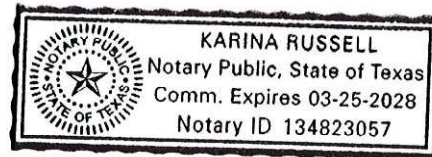
