SECTION 1.0 – SITE VISITS:

All prospective bidders can schedule a site visit through Tim Hoskins with the Department of General Services between 8:00 a.m. and 3:00 p.m. Monday through Friday. Mr. Hoskins can be reached at 504-364-2675

SECTION 2.0 – SCOPE:

We extend this bid to provide labor, materials, delivery, equipment, and all other incidentals necessary to clean and refinish several bronze statutes, bases, and plaques at 3301 Veterans Memorial Blvd Metairie, La 70002.

SECTION 3.0 – QUANTITIES/INSPECTION:

Bidders must inspect the site and perform their own measurements to determine the proper quantity of labor, materials, and equipment required to complete this project.

SECTION 4.0 - BID SPECIFICATIONS:

4.1 Cleaning:

- Perform written and photographic documentation before and after the project.
- Remove any dust/ debris from the statues and plaques using a soft wash with a brush or cloth method.
- Clean statues, bases, and plaques using SURFONIC® JL-80X surfactant non-ionic detergent.
- Rinse all statues and plaques thoroughly with clean water to remove any soap residue.
- Dry all statues and plaques entirely with a soft cloth.

4.2 Polishing:

- All tarnishes and patina shall be removed per the manufacturer's recommendations. Apply polish according to the manufacturer's instructions using a soft cloth or applicator.
- Apply protective wax by gently heating the statues and plaques.
- Apply a layer of cold wax over the statues and plaques once the hot wax dries.
- Buff the statues and plaques with a clean, dry cloth to restore their luster.

4.3 Sealing:

- Apply sealant per manufacturer's recommendations.
- Apply a protective sealant to prevent future tarnishing or corrosion.
- Apply a sealant that is specifically formulated for bronze or metal surfaces.
- Follow the manufacturer's instructions for applying the sealant.

4.4 Plaques and Statues:

- Police + Fire with Children Statue to include (27) small name plaques
- Two (2) medium plaques facing Causeway Blvd
- One 1 Large Plaque in the Middle
- Lions Club Area to Include five (5) Logos and a lockbox on the back of the marble podium. Cost
- Navy Stand with Large Black Plaque
- Blue Star Plaque (Front and Rear Sides) - Paint to match existing with automotive grade acrylic
- Harry Lee Statue and Large Plaque under the statue
- Eagle Statue with base and (4) Large Plaques
- JP Purple Heart Square Extra Large Plaque

SECTION 5.0 – CLEANING AREA AND SAFETY:

The job site must be clean and free of all litter and debris caused by this work daily and upon contract completion. Passageways must always be kept clean and free of material, equipment, and debris. Storage of flammable materials will not be permitted on the premises. All combustible materials must be removed from the job site daily. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

SECTION 6.0 – EXISTING STRUCTURE:

If the successful bidder damages or destroys any part of a building, vehicle, parking lot, fencing, landscaping, etc., the successful bidder shall be required to replace and restore said items to their original condition with the same type of material, finish, and workmanship at no additional cost to the owner.

SECTION 7.0 – LIQUIDATED DAMAGES:

Commencing on the thirty-first day following the notice to proceed until work is substantially complete, liquidated damages will be assessed for \$300/day.

SECTION 8.0 – PRE-CONSTRUCTION CONFERENCE AND NOTICE TO PROCEED:

Before any work commences, a Pre-Construction Conference shall be held between the successful bidder and the owner.

No materials shall be ordered until the successful bidder receives a written “Notice to Order Materials” from the Department of General Services.

No work shall be performed until the successful bidder receives a written “Notice to Proceed” from the Department of General Services to begin work.
