**SECOND ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION OF

The undersigned, acting pursuant to Louisiana's limited liability company law, R.S. 12:1309, et. seq., and constituting all of the Members of Intelligent Transportation Systems LLC, adopt the following Second Articles of Amendment to Articles of Organization, amending the Articles of Organization of Intelligent Transportation Systems LLC, as previously amended, to read in their entirety as follows:

**ARTICLE I  
NAME**

The name of the limited liability company is "Intelligent Transportation Systems LLC."

**ARTICLE II  
PURPOSE**

The purpose of the Company is to conduct any lawful activity for which limited liability companies may be formed.

**ARTICLE III  
MANAGEMENT BY MANAGERS**

The Company shall be managed by a Manager elected by a majority vote of the Members.

**ARTICLE IV

**ARTICLE V  
RELIANCE OF CERTIFICATE**


Persons dealing with the Company may rely upon a certificate bearing the signature of the Manager to establish the membership of any member, the authenticity of any records of the Company, or the authority of any person to act on behalf of the Company, including but not limited to the authority to take the actions referred to in La. R.S. 12:1318(B).

**ARTICLE VI**  
**TERM**

The Company shall have perpetual existence.




