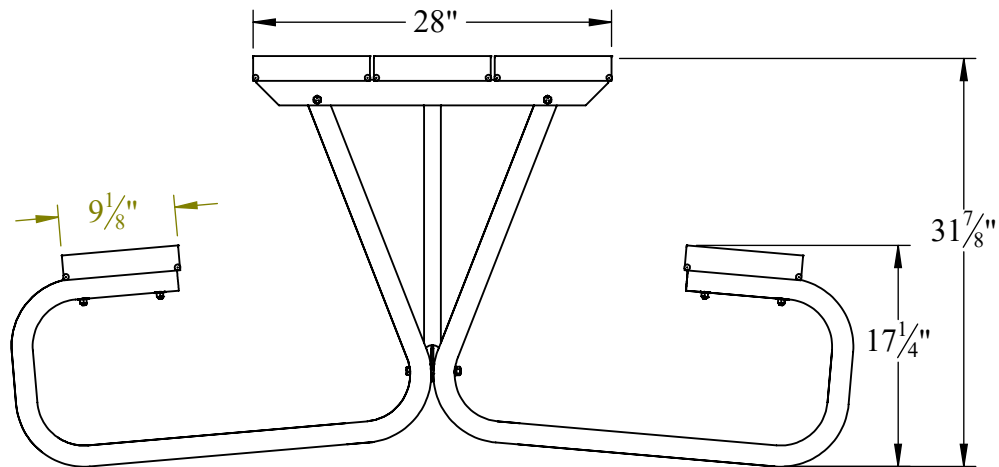
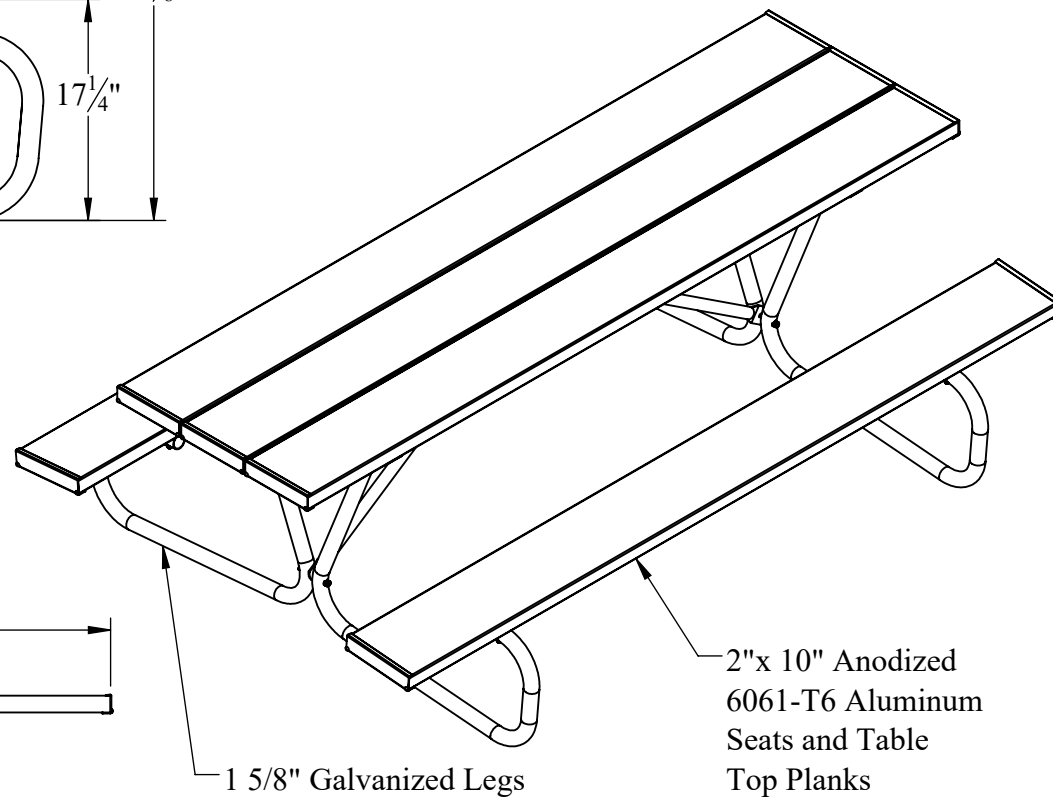
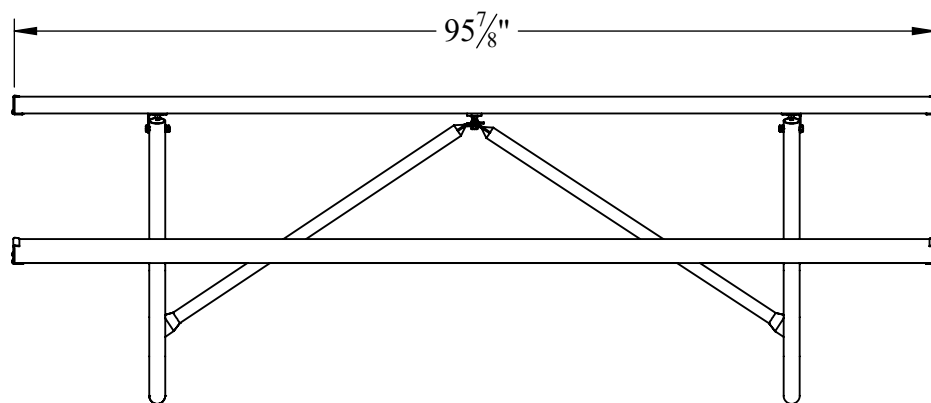
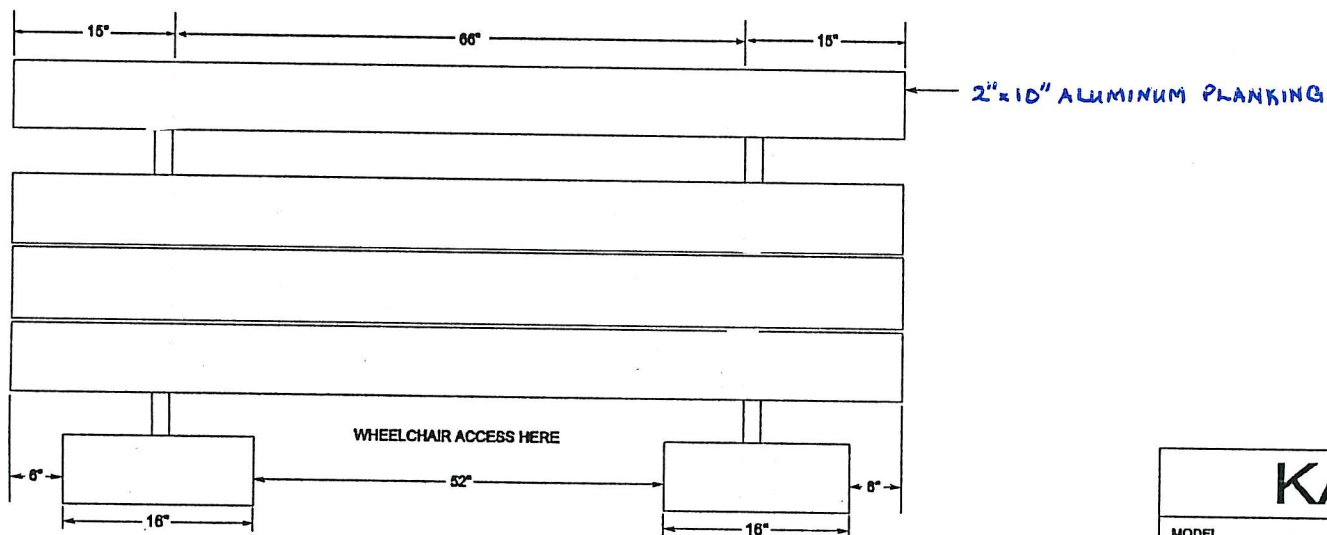
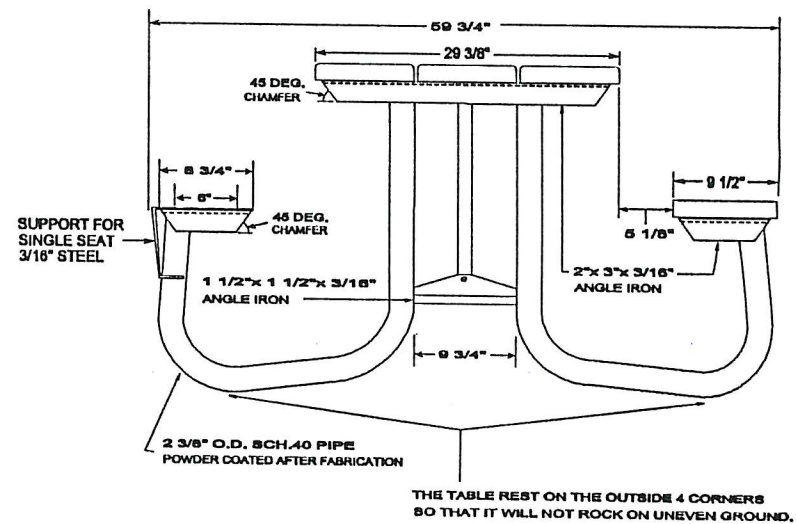
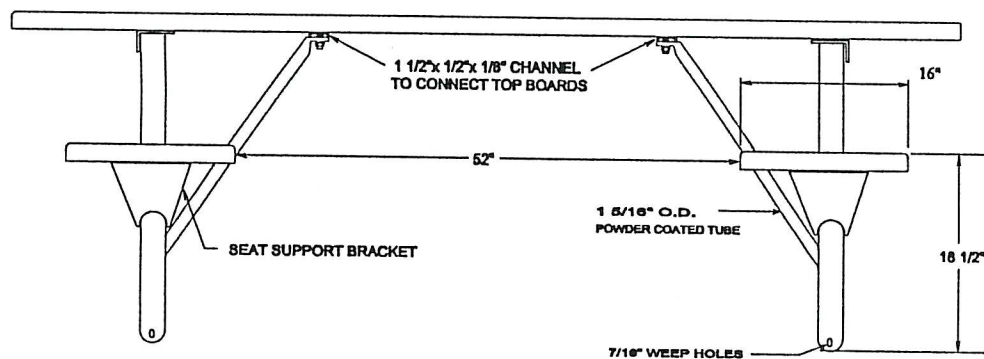


TABLE RESTS ON OUTSIDE 4
