Section 1.0 – Site Visits:

There will be no pre-bid meeting for this project. The Bidder will be responsible for all measurements, etc.

All site visits should be arranged through Brent Griffin at 504-349-5000, or cell (504)419-4415, Monday – Friday from 8:00 am to 5:00 pm.

Section 2.0- Scope:

We extend this bid to cover all labor, materials, and equipment for the re-surfacing and replacement on wall panels and trim, spray Triton Tritoflex 2K, or approved equal, Liquid Rubber, over 8" area of vertical panel and turned under 4" of bottom trim to encapsulate all areas of rust. Also spray Triton Tritocryl IK, or approved equal, white finish, over rubber coated area. Fabricate 6 cover panels 6' tall in damaged areas at Grand Isle Pavilion.

Section 3.0-License Requirements:

The following Louisiana State license shall be required for this project:

- Building Construction

NOTE- Louisiana State Contractors License number shall be on the outside of the bid envelope. The license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected.

Section 4.0 - Bond Requirements

A bid surety bond must be submitted with your bid in the amount of 5% of your total bid. Vendor must submit an electronic bid bond through the respective online clearinghouse bond management system as indicated in the electronic bid solicitation on Central Auction House. No scanned paper copies of any bid bond will be accepted as part of the electronic bid submission.

A performance bond in 50% of the contract price is required at the signing of the formal contract.

A payment bond in 50% of the contract price is required at the signing of the formal contract.

Section 5.0 - Quantities/Inspection:

The estimated linear foot of spray is 450 feet, but the Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

Section 6.0 - Bid Specifications:

The successful bidder shall supply all labor, materials, equipment, and necessary essentials to perform the following:

- Fabricate and install 6 cover panels 6' tall at damaged panel areas.
- Straighten and install galvanized bottom flashing where necessary at damaged areas.
- Install a straight-line tape on side and front walls 8" up from the bottom and 4" on the bottom.
- Spray Triton TritoFlex 2K Liquid Rubber, or approved equal, over 8" area of vertical wall and turned under 4" on bottom trim.
- Spray Triton TritoCryl IK White Finish Coat, or approved equal, over Liquid Rubber spray.
- If the vendor is not using the Triton Product mentioned herein, substitutes must be approved by the Recreation Department.
- Equipment used to administer sprays must be designed for the application of Liquid Rubber Membrane.
- Prior to application, all surfaces will be pressure washed by Owner. This will not be the responsibility of the awarded vendor. Other pre-application cleaning required by manufacturer's products will be the responsibility of the vendor. Additionally, the removing and reinstalling of existing lights will be the responsibility of the Owner.
- All job related debris must be removed.

Section 7.0 - Hours of Work:

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days in advance. The successful bidder shall work normal building working hours (8:00am - 4:00pm) to provide a safe work environment at no extra charge to Jefferson Parish.

Section 8.0 - Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premise. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 9.0 - Existing Structure

Should any cutting, patching, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

Section 10.0 - Warranty:

A two (2) year warranty, from the date of the Notice To Proceed, on all materials and workmanship shall be included. The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections which may be required to make good all defects in materials and/or equipment under its intended use, within the warranty period, at no cost to the owner.

Section 11.0 - SDS:

The bidder shall notify the Jefferson Parish Department of Parks and Recreation contact person of any hazardous substances that will be brought to and/or used at the workplace. The bidder shall provide SDS as per this requirement to the Director of the Jefferson Parish Department of Parks and Recreation.

Section 12.0 - Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement and/or the City of Gretna. The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project.

Section 13.0 - Pre-Construction Conference and Notice to Proceed:

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work, from the Department of Parks and Recreation.

Section 14.0- CONSTRUCTION TERM

Upon receiving a notice to proceed, the Bidder agrees that all work shall be completed as follows: Vendor agrees to commence actual physical work on the site with an adequate force and equipment within five (5) days from the date of Notice of Proceed. All work shall be substantially completed in seven (7) consecutive calendar days from date of Notice to Proceed.


