

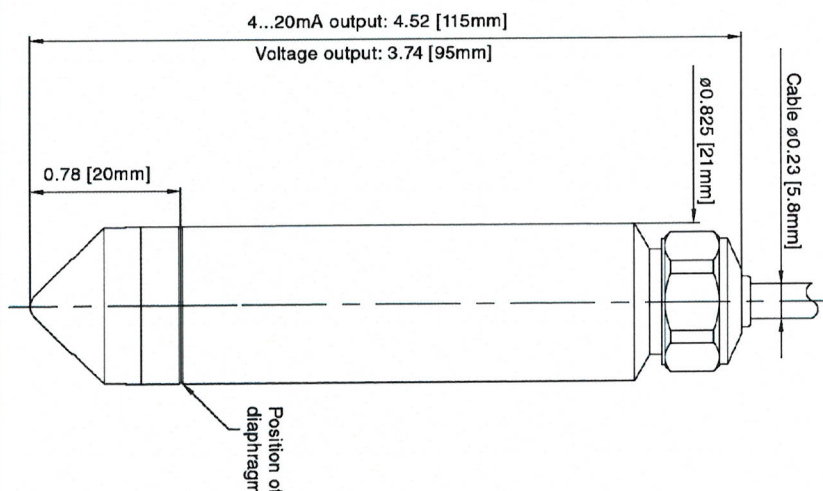

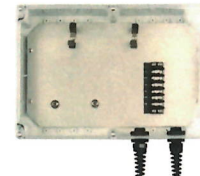

In addition, cable resistance (~70Ω / 1000ft) adds to the supply requirement. In order to insure proper system operation, calculate the minimum required supply voltage (at the source) as follows:

For two-part (internal+external) system (recommended):
 $\text{MINIMUM SUPPLY VOLTAGE} = 11.6 + 0.022 (\text{CABLE LENGTH} \times 0.07) \text{ VDC}$

For internal only protector (standard with 4-20mA output):
 $\text{MINIMUM SUPPLY VOLTAGE} = 11 + 0.022 (\text{CABLE LENGTH} \times 0.07) \text{ VDC}$
