### **Section 2.0 - Scope:**

We extend this bid to provide labor, equipment, and materials necessary to perform the following work on the kitchen area of Traffic Engineering:

### **Section 3.0 –License Requirements:**

### **Section 4.0 – Quantities/Inspection:**
