Basic fault coverage includes Conflict, Red Fail, CVM, 24V-1 and 24V-11. Dual indication monitoring detects simultaneous active signals on a channel. Clearance monitoring assures proper sequencing of signals and a minimum yellow clearance interval. AC Line monitoring responds to low AC Line voltages as well as interruptions.

High contrast, large area Liquid Crystal Displays (LCD) show full intersection status with an active Red, Yellow, Green, and Walk indicator for each channel.


