**1.01. GENERAL:**

The bidder shall supply one (1) Layne and Bowler 10WALC-3 state vertical turbine pump, or approved equal, as a direct replacement. This unit must fit the existing system with no modifications by using the existing motor. The unit under this bid shall be furnished by the area authorized factory representative for Jefferson Parish, Louisiana, and for the brand being offered. Any bids submitted for the alternate unit manufacturers, other than that as specified, must include in their bid all information needed to fully demonstrate complete compliance with requirements of these specifications and dimensional duplicity of the existing unit. It is the bidder's responsibility to provide adequate information necessary for the complete evaluation of their proposed equipment. Jefferson Parish shall be the sole judge as to the equality of any alternate manufacturer's offering. Proper measurements must be confirmed by the pump supplier including discharge height, overall depth, etc.

**2.01 PUMPS:**

1. Pump shall be of the vertical turbine type.
2. Pump shall be built to standard dimensions such that parts will be interchangeable between existing two pumps already in service at the Bridge City Plant.
3. Pump shall be supplied by Aurora Verti-Line 10RKLC, Fairbanks Morse, or approved equal.



### **3.01 PUMP CONSTRUCTION:**

#### **Bowl**

Shall be cast iron construction / bronze fitted materials of construction, suction bell, no strainer, C93200 bronze sand collar, 416 SS tapered lock collets, 316 SS impellers, bronze bowl wear rings, 416 SS bowl shaft and threaded coupling, C84400 bronze bearing, open line shaft connection, 6 inch threaded discharge case, Tnemec N140 white epoxy coating, exterior, 2 coats.

#### **Column**

6 inch diameter threaded column pipe assembly not to exceed 5 feet in length, water lubricated, open line shaft – 1 inch diameter shaft, 416 SS line shaft and threaded coupling, no sleeves, bronze spiders with rubber line shaft bearings, Tnemec N140 white epoxy coating, exterior, 2 coats.

#### **Discharge Head**

Model F612 fabricated steel, above base discharge head, 6 inch 150# ANSI class discharge flange, raised face, 12 inch BD motor pedestal, lifting lugs, *Head to match original center line up and out and base dimensions of existing piping*, no sole plate, 416 SS threaded sleeve type motor coupling and drive shaft, bronze adjusting nut, RNL cast iron deep bore bypass packing box with bronze glands, 304 SS head hardware, Tnemec N140 white epoxy coating, interior, 2 coats, standard exterior coating, green.

### **4.01 Service:**

The pump bidder shall be listed as a factory authorized service center for the brand they are bidding and be capable of completely servicing the proposed pumps within one (1) hour travel time of the project site. The pump bidder must have a direct factory service center and stocking facility capable of completely servicing and supplying spare parts for the proposed pump within one (1) hour travel time of the project site. The bidder's factory service center facility shall be available for Jefferson Parish inspection on a twenty-four (24) hour prior notice. The bidder's service center must have full time, factory trained mechanics certified to service the equipment being offered.

#### **5.01 Warranty:**

The pump unit or any parts thereof shall be warranted against defects in material or workmanship within one year from date of installation or 18 months from date of manufacture, whichever comes first, and shall be replaced at no charge with a new or manufactured part, F.O.B factory or authorized warranty service center.
