Note: Freight and installation are quoted at current rates and are valid for (30) days. This is due to fluctuating fuel and airline costs. Once freight and installation dates are confirmed, these price will be adjusted and any difference will be passed on as a change order. When these dates are confirmed we require at least (2) weeks lead time so that Ideal Image can secure travel at an optimum cost. If the install schedule is changed after written confirmation, any additional costs for rescheduling travel must be passed on as a change order.

Terms: Ideal Image requires a 50% deposit upon order placement. The remaining balance will be due as follows: 45% is due upon component completion or prior to shipment, whichever is first. (The aforementioned 95% must be received prior to shipment and scheduling of installation). The remaining 5% is due upon installation completion in conjunction with full customer satisfaction.

Any applicable sales/use tax is the responsibility of buyer. In the event Ideal Image is required to remit any sales/use tax, buyer agrees to reimburse Ideal Image for the tax amount or provide written proof of direct payment. If this purchase is for resale, buyer agrees to include a resale certificate with the signed acceptance.
